Norwood School Crown Dale London SE19 3NY Variation of condition 2 (Approved Plans) of planning permission 18/03425/FUL (Erection of a single storey prefabricated modular classroom building to provide 2 classrooms with associated store rooms for a temporary period of 5 years) granted on 23.10.2018.
