(TOOTING BEC GARDENS) VARIATION ORDER 2019 1. Transport for London hereby gives notice that on 22nd January 2019 it made the above named Orders, under section 6 of the Road Traffic Regulation Act 1984. The Orders will come into force on 28th January 2019.

- 2. The general nature and effect of the Orders will be to: 1) ban all vehicles proceeding north-eastbound on Mitcham Lane
  - from turning right into Streatham High Road southbound; 2) introduce a new 136 metre Bus Lane on Tooting Bec Gardens eastbound between Nos. 22 Tooting Bec Gardens and the southern build line of St Leonard's Church. The bus lane will operate
  - Monday to Friday 7am to 7pm; 3) remove the existing Parking Bays outside Nos. 12 to 16, 22 and 26 Tooting Bec Gardens and replace with Single Red Lines 'No Stopping, Monday-Friday 7am - 7pm;
  - 4) relocate the existing 6.6 metre Disabled Persons' Vehicles Only Bay outside No.10 Tooting Bec Gardens to on the footway outside No.18 Tooting Bec Gardens.
- 3. The roads which would be affected by the Orders are the A216 GLA Road - Mitcham Lane, A214 GLA Road - Tooting Bec Gardens in the
