ROAD TRAFFIC REGULATION ACT 1984

THE A 100 GLA ROAD (TOWER BRIDGE ROAD, LONDON BOROUGH OF TOWER HAMLETS AND SOUTHWARK) (TEMPORARY RESTRICTION OF TRAFFIC IN CONNECTION WITH FILMING) ORDER 2019

- 1. Transport for London hereby gives notice that it intends to make the above named Traffic Order under section 16(A) of the Road Traffic Regulation Act 19841a, as amended and of all other enabling powers, and after consulting the Commissioner of Police of the Metropolis and the London Boroughs of Southwark and Tower Hamlet for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- The purpose of the Order is to enable filming to take place on the A100 GLA Road Tower Bridge.
- 3. The effect of the Order will be to:
 - (I) prohibit any vehicle from entering, exiting or proceeding on the A100 Tower Bridge Road, Tower Bridge and Tower Bridge Approach between its junction with Tooley Street and a point 130 metres south of its junction with East Smithfield. From 1:00 AM to 5:00 AM on Saturday 23rd November 2019;
 - (2) prohibit pedestrians from proceeding on the western footway of the A100 Tower Bridge between a point 265 metres south of the junction of East Smithfield and Tower Bridge Approach and a point 190 metres north of the junction of Queen Elizabeth Street and Tower Bridge Road. From 6:00 PM on Friday 22rd November 2019 until 6:00 AM on Saturday 23rd November 2019;
 - (3) permit all vehicles to proceed in a westerly direction on Tooley Street between its junctions with Fair Street and Potters Fields. From 1:00 AM to 5:00 AM on Saturday 23rd November 2019;
 - (4) allow temporary holds to occur for short durations at these locations. From 6:00 PM on Friday 22nd November 2019 until 1:00 AM on Saturday 23rd November 2019 and then again from 5:00 AM to 6:00 AM on Saturday 23rd November 2019.

The Order will be effective from 6:00 PM on 22nd November 2019 to 6:00 AM on 23rd November 2019 or until the filming has been completed. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- 4. The prohibitions will not apply in respect of:
 - (I) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
