ROAD TRAFFIC REGULATION ACT 1984

THE A201 GLA ROAD AND SIDE ROADS (BLACKFRIARS ROAD, UNION STREET AND THE CUT, LONDON BOROUGHS OF SOUTHWARK AND LAMBETH) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2020

1. Transport for London hereby having consulted the London Boroughs of Southwark and Lambeth gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to restrict traffic on the A201 Blackfriars Road, The Cut and Union Street because of the likelihood of danger to the public or of serious damage to the road due to a burst water main on the A201 Blackfriars Road.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering, exiting, or proceeding on the A201 Blackfriars Road between its junctions with Southwark Street and St George's Circus. Local access only will be maintained between its junctions with St George's Circus and Ufford Street and between its junctions with Southwark Street and Scoresby Street;
 - (2) entering, exiting or proceeding on The Cut between its junctions with Waterloo Road and Blackfriars Road. Local access only will be maintained between its junctions with Waterloo Road and Greet Street;
 - (3) entering, exiting or proceeding on Union Street between its junctions Southwark Bridge Road and Blackfriars Road. Local access only will be maintained.

The Order will be effective at certain times from 12.01 AM on the 1st February 2020 until 11.59 PM on the 21st April 2020 or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs via **(for the closure of Blackfriars Road) (for northbound traffic)** Borough Road, Southwark Bridge Road and Southwark Street to normal route of travel **(for southbound traffic)** Stamford Street and Waterloo Road, **(for the closure of The Cut)** Waterloo Road north-westbound and Stamford Street or Waterloo Road south-east bound to normal route of travel **(for the closure of Union Street)** Great Suffolk Street northbound and Southwark Street or Great Suffolk Street southbound, Southwark Bridge Road and Borough Road to normal route of travel.
