

# Transport for London Notice

## ROAD TRAFFIC REGULATION ACT 1984

### THE A23 GLA ROAD (BRIXTON ROAD/BRIXTON HILL, LONDON BOROUGH OF LAMBETH) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2020

1. Transport for London in consultation with the London Borough of Lambeth hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable kerb realignment, footway resurfacing and carriageway resurfacing works to take place on the A23 Brixton Road and Brixton Hill.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) entering, exiting, proceeding or stopping on Coldharbour Lane between its junctions with Electric Avenue and Brixton Road/Brixton Hill;
  - (2) entering or proceeding on Brixton Hill southbound between its junctions with Acre Lane/Effra Road and Sudbourne Road;
  - (3) turning right from Acre Lane into Brixton Hill and Effra Road;
  - (4) entering or exiting Electric Avenue at its junction with Brixton Road;
  - (5) stopping on Brixton Road at the eastern kerb line between its junctions with Atlantic Road and Coldharbour Lane;

The Order will also allow all vehicles to use the southbound bus lane on:

- (6) Brixton Road between its junctions with Atlantic Road and Coldharbour Lane;
- (7) Brixton Hill between its junctions with Brixton Road and Sudbourne Road.

The Order will be effective from 8:00 AM on the 16th February 2020 until 6:00 AM on the 19th February 2020 or until the works has been completed. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For Brixton Hill southbound via Effra Road and Brixton Water Lane to normal route of travel. For Coldharbour Lane via Brixton Hill, Brixton Water Lane, Effra Road, Morval Road, Dalberg Road, Dulwich Road, Hurst Street, Railton Road and Atlantic Road to normal route of travel.
