

# Transport for London Notice

## ROAD TRAFFIC REGULATION ACT 1984

### THE A21 GLA ROAD (BROMLEY ROAD, LONDON BOROUGH OF LEWISHAM) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2020

1. Transport for London hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order on the A21 Bromley Road is to enable carriageway resurfacing works.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) Entering or exiting Bromley Road between its junction with Daneby Road and Watermead Road;
  - (2) Stopping on Bromley Road between its junctions with Crantock Road and Southend Lane/ Whitefoot lane;
  - (3) Turning right from Callander Road into Bromley Road;
  - (4) Entering, exiting, proceeding or stopping on Bellingham Road between its junction with Bromley Road and the extended eastern building line of No.4 Bellingham Road.

The Order will be effective from 9:00 PM on the 21st January 2020 until 06:00 AM on 31st March 2020 or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs.
  - a) For southbound A21 Bromley Road to eastbound Bellingham Road via Bromley Road, Daneswood Avenue, Woodham Road and Conisborough Crescent to normal route of travel;
  - b) For southbound A21 Bromley Road to westbound Randlesdown Road via Bromley Road, Southend Lane and Brookehowse Road to normal route of travel;
  - c) For westbound Bellingham Road to Bromley Road via Thornsbeach Road and Culverley Road to normal route of travel;
  - d) For northbound A21 Bromley Road to eastbound Bellingham Road via Bromley Road, Culverley Road and Thornbeach Road to normal route of travel;
  - e) For eastbound Randlesdown Road to A21 Bromley Road via Brookehowse Road, Fordmill Road and Canadian Avenue to normal route of travel;
  - f) For northbound A21 Bromley Road to westbound Randlesdown Road via Bromley Road, Canadian Avenue, Fordmill Road and Brookehowse Road to normal route of travel.
