**St Thomas' Hospital 249 Westminster Bridge Road**

**London SE1 7EH** Removal of Robert Clayton Statue located at the entrance of St Thomas' Hospital.

**Plot 64-68 Rectory Grove London** Erection of three new 3 storey dwellinghouses plus basement and rear dormers, including the provision of refuse and cycle stores to the rear with new entrance access via Rectory Gardens. 20/01664/FUL

**89 Larkhall Rise London SW4 6HR** Erection of a lower ground floor single storey rear extension and alterations to front access at lower ground floor level.
