

# Transport for London Notice

## ROAD TRAFFIC REGULATION ACT 1984

### THE A3 GLA ROAD (BOROUGH HIGH STREET, LONDON BOROUGH OF SOUTHWARK) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2020

1. Transport for London hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is because of the likelihood of danger to the public due to the coronavirus pandemic various traffic, parking and loading restrictions in London Borough of Southwark have been altered to enable social distancing to take place.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) Entering, exiting, proceeding or stopping on Borough High Street between its junctions with Tooley Street and Union Street;
  - (2) Entering or exiting St Thomas Street at its junction with Borough High Street;
  - (3) Entering or exiting Stoney Street at its junction with Southwark Street;
  - (4) Stopping in the loading and unloading bay outside Nos. 31 - 41 Borough High Street;
  - (5) Stopping in the loading and unloading bay outside Nos. 63 - 73 Borough High Street;
  - (6) Stopping in the loading and unloading bay outside Nos. 30 - 34 Borough High Street;
  - (7) Stopping in the loading and unloading bay outside No. 6 Southwark Street;
  - (8) Stopping in the loading and unloading bay outside No. 8 St Thomas Street;
  - (9) Stopping in the pay and display borough bays outside Nos. 8 - 26 St Thomas Street;
  - (10) Stopping in the licensed taxi only bay outside Guy's Hospital on St Thomas Street

The Order will be effective at certain times from 12.01 AM on the 3rd July 2020 until 11:59 PM on the 31st December 2021 or when the social distancing measures are not required, whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of for the purposes of those restrictions or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force, alternative routes will be indicated by traffic signs via: **[for southbound traffic on London Bridge]** via Tooley Street, Tower Bridge Road, Bricklayers Arms Roundabout, Great Dover Street to normal route of travel. **[for northbound traffic on Borough High Street]** via Marshalsea Rd, Southwark Bridge Rd, Southwark Bridge, Upper Thames Street, Lower Thames Street, Tower Hill, Minories, Goodman's Yard, Mansell Street to normal route of travel. **[for eastbound traffic on Southwark Street]** via Southwark Bridge Road, Southwark Bridge, Upper Thames Street, Lower Thames Street, Tower Hill, Tower Bridge to normal route of travel.
