## Road Traffic Regulation Act 1984 The Lewisham (School Streets – phase 1a (i)) (Covid-19) (Temporary Prohibition of Traffic) Order 2020 NOTICE IS HEREBY GIVEN that Lewisham Council made this temporary

traffic order under the provisions of section 14(1) of the Road Traffic Regulation Act 1984 as amended by The Traffic Orders Procedure (Coronavirus) (Amendment) (England) Regulations 2020 because of the

likelihood of danger to the public on and adjacent to the highway, and that it was necessary to make the order for purposes connected to coronavirus so as to maintain social distancing on and adjacent to the highway at various school locations. The order allows for road closures to be

(adjacent to Conisborough College) and Forster Memorial Park. There

- at various school locations. The order allows for road closures to be implemented at school arrival and departure times for social distancing reasons. The effects of the order are indicated below.

  1. Road closure and no parking & waiting for all motor vehicles in:(i) The access road between the southern extent of Thornsbeach Road
- (ii) Adamsril Road, between a point 9.1 meters east of the projected eastern kerbline of Fairwyn Road and a point 4.6 meters west of the projected western kerbline of Champion Road.

are no alternative routes for affected traffic.

- The alternative routes shall be via Fairwyn Road, De Frene Road, Perry Rise and Adamsril Road.
- (iii) Angus Street, between a point 5.4 meters east of the eastern building line of No.7 Angus Street and the western extent of Angus Street.

There are no alternative routes for affected traffic.

(iv) Ashmead Road, between a point 1.8 meters west of the projected

- western kerbline of St. John's Vale and a point 1.7 meters east of the projected eastern kerbline of Friendly Street.

  The alternative routes shall be via St. John's Vale, Lewisham Way and
- The alternative routes shall be via St. John's Vale, Lewisham Way and Friendly Street.
- (v) Ewhurst Road, east of Manwood Road, between a point 2.8 meters east of the projected eastern back of footway line of Manwood Road and the southern extent of Ewhurst Road.
- There are no alternative routes for affected traffic.

  (vi) Kelvin Grove, between the projected back of footway line on Kirkdale,
- western side, to the south-western extent of Kelvin Grove.
- There are no alternative routes for affected traffic.
- No parking & waiting at any time in Thornsbeach Road, between the southern kerbline of Bellingham Road and the southern extent of Thornsbeach Road
   Exemption is provided in the order for vehicles being used for ambulance, fire brigade or police purposes in an emergency and anythin
- ambulance, fire brigade or police purposes in an emergency and anything done with the permission or at the direction of a police officer in uniform, and any vehicle authorised by London Borough of Lewisham. Exemption is also provided for any vehicle being used in connection with the removal of any obstruction to traffic; the maintenance, improvement, reconstruction, cleansing or lighting within the street; the laying, erection, alteration in or adjacent to the street of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any electronic communications network (within the meaning of the Communications Act
- communications network [within the meaning of the Communications Act 2003], or the placing, maintenance or removal of any traffic sign in the street.

  4. The order comes into force on the 5th October 2020 to remain in force
- for up to 18 months.

  5. The prohibitions apply as, when and to the extent signed on the highway.
