

Transport for London Notice

ROAD TRAFFIC REGULATION ACT 1984

THE A5 GLA ROAD (EDGWARE ROAD, CITY OF WESTMINSTER) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2020

1. Transport for London hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable resurfacing and junction improvements works to take place on Edgware Road.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering, exiting, proceeding or stopping on Connaught Street between its junctions with Portsea Place and Edgware Road;
 - (2) entering, exiting, proceeding or stopping on Edgware Road between its junctions with Seymour Street and Kendal Street;
 - (3) entering, exiting, proceeding or stopping on Edgware Road between its junctions with Bayswater Road and Seymour Street;
 - (4) entering, exiting, proceeding or stopping Praed Street between its junctions Sale Place and Edgware Road;
 - (5) entering, exiting, proceeding or stopping on Edgware Road between Harrow Road and Sussex Gardens;
 - (6) entering, exiting or proceeding on Chapel Street between its junctions with Cappel Street and Edgware Road;
 - (7) entering, exiting, proceeding on Upper Berkeley Street between its junctions with Seymour Place and Edgware Road.

The Order will also:

- (8) permit two-way operation on Praed Street between its junction with Norfolk Place and Edgware Road;
- (9) permit two-way operation on Chapel Street between its junctions with Old Marylebone Road and Edgware Road, marshals to be provided to maintain local access on Chapel Street.

Works will be phased such that not all restrictions will apply at any one time.

The Order will be effective at certain times from 12:01 AM on the 5th December 2020 until 6:00 PM on the 31st May 2021 or when those works have been completed, whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs:
 - (1) For Edgware Road Southbound closure via Harrow Road, Bishops Bridge Road, Westbourne Terrace, Westbourne Street and Bayswater Road to normal route of travel;
 - (2) For Edgware Road northbound closure at the junction with Praed Street via Sussex Gardens, Westbourne Terrace, Bishop's Bridge Road and Harrow Road to normal route of travel;
 - (3) For Edgware Road northbound closure at Connaught Street via Bayswater Road, Westbourne Street, Westbourne Terrace, Bishop's Bridge Road and Harrow Road to normal route of travel;
 - (4) For Praed Street closure via London Street, Sussex Gardens, Old Marylebone Road and Harrow Road to normal route of travel.
