ROAD TRAFFIC REGULATION ACT 1984

THE A202 GLA ROAD (CAMBERWELL NEW ROAD/CAMBERWELL CHURCH STREET) AND GLA SIDE ROADS (CAMBERWELL GREEN AND DENMARK HILL, LONDON BOROUGH OF SOUTHWARK AND LAMBETH) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2021

1. Transport for London in consultation with The London Boroughs of Southwark and Lambeth hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
 2. The purpose of the Order is for resurfacing works to take place on the A202 GLA Road - Camberwell New Road/ Camberwell Church Street and GLA Side Roads – Camberwell Green and Denmark Hill.
 3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering or proceeding on Camberwell New Road eastbound between its junctions with Brixton Road and Camberwell Passage, local access will be maintained;
 - (2) entering, exiting or proceeding on Camberwell New Road between its junctions with Camberwell Passage and Camberwell Church Street, except buses;
 - (3) stopping on Camberwell New Road between its junctions with Camberwell Church Street and Medlar Street;
 - (4) entering, exiting, proceeding or stopping on Warner Road between its junctions with Camberwell New Road and Tillings Close;
 - (5) entering or proceeding on Denmark Hill between its junctions with Coldharbour Lane and Camberwell Green, except buses;
 - (6) entering, exiting, proceeding on Denmark Hill southbound between its junctions with Camberwell New Road/ Camberwell Church Street and Coldharbour Lane;
 - (7) stopping on Denmark Hill between its junctions with Camberwell Green and Coldharbour Lane;
 - (8) entering or proceeding on Denmark Hill northbound between its junctions with Campion Park and Coldharbour Lane, except local access and buses;
 - (9) entering or proceeding on Walworth Road/Camberwell Road between its junctions with Newington Butts and the northern arm of Camberwell Green, except local access;
 - (10) entering or proceeding on Camberwell Green between its junctions with the northern arm of Camberwell Green and Denmark Hill, except buses;
 - (11) stopping on Camberwell Green between its junctions with Bullace Row and Denmark Hill;
 - (12) entering or proceeding on A202 Queens Road/ Peckham High Street/Peckham Road/ Camberwell Church Street westbound between its junctions with New Cross Road and Grove Lane, except local access;
 - (13) entering or proceeding on Camberwell Church Street Green between its junctions with Grove Lane and Camberwell New Road, except buses;
 - (14) entering, exiting or stopping on Camberwell Church Street between its junctions with Benhill Road and Camberwell New Road;
- This Order will also permit all vehicles to use the bus lanes on:
- (15) Camberwell Green between its junctions with Bullace Row and Camberwell Church Street / Camberwell New Street;
 - (16) Camberwell Church Street between its junctions with Benhill Road and Camberwell New Road;
 - (17) Camberwell New Road between its junctions with Camberwell Station Road and Camberwell Church Street;
 - (18) Denmark Hill between its junctions with Coldharbour Lane and Camberwell Green.
- The Order will also permit two way operation on Kimpton Road between its junctions with Camberwell Church Road and Harvey Road.
- Works will be phased such that not all restrictions may apply at any one time.
- The Order will be effective at certain times from 22nd February 2021 until the 31st March 2021 every night 8:00 PM to 5:00 AM or when those works have been completed, whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
 5. At such times as the prohibitions are in force an alternative route will be indicated by traffic signs:
 - (1) For closures of Camberwell New Road/Camberwell Church Street via Kennington Park Road, Newington Butts, Elephant and Castle, New Kent Road, Old Kent Road and New Cross Road or reverse to normal route of travel;
 - (2) For closure of Denmark Hill via Campion Park, Grove Lane, Dog Kennel Hill, Grove Vale, East Dulwich Road, Nunhead Lane, Consort Road, Clayton Road, Peckham High Street, Peckham Road and Camberwell Church Street or reverse to normal route of travel;
 - (3) For Elephant and Castle to Denmark Hill southbound via New Kent Road, Old Kent Road, New Cross Road, Pomeroy Street, Lausanne Road, Evelina Road, Nunhead Lane, East Dulwich Road, Grove Vale, Dog Kennel Hill, Grove Lane and Campion Park or reverse to normal route of travel.
