ROAD TRAFFIC REGULATION ACT 1984

THE A406 AND A205 GLA ROADS (NORTH CIRCULAR ROAD AND JOHN WILSON STREET, LONDON BOROUGH OF BRENT AND ROYAL BOROUGH OF GREENWICH) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2021

1. Transport for London having consulted the London Borough of Brent and Royal Borough of Greenwich hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable ULEZ signage and street furniture installation works to take place at various locations in the London Borough of Brent and Royal Borough of Greenwich.
3. The effect of the Order will be to prohibit any vehicle from entering or proceeding on:
 - (1) Heather Road between its junction with North Circular Road and the southern boundary line of No.834 North Circular Road;
 - (2) Links Road between its junction with North Circular Road and the southern boundary line of No.1 Links Road;
 - (3) Randall Avenue between its junction with North Circular Road and the northern boundary line of No.728 North Circular Road;
 - (4) the southeast-bound carriageway of A4088 Dudden Hill Lane at its junction with Dollis Hill Lane.

Local access will be maintained in all road closures.

The Order will be effective at certain times from 12:01 AM on 4th May 2021 and ending at 11:59 PM on 31st December 2021 or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibition is in force an alternative route will be indicated by traffic signs via for the closure of: (Heather Road) Links Road, Review Road to normal route of travel; (Links Road) Heather Road and Links Road to normal route of travel; (Randall Avenue) Links Road, Warren Road, Heather Road and Crest Road to normal route of travel; (Dudden Hill Lane) Neasden Lane and Bermans Way to normal route of travel.
