ROAD TRAFFIC REGULATION ACT 1984

THE A101 GLA ROADS (ROTHERHITHE TUNNEL AND BRANCH ROAD, LONDON BOROUGH OF SOUTHWARK AND TOWER HAMLETS) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2021

1. Transport for London hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable lighting works to take place in A101 Rotherhithe Tunnel.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering, exiting or proceeding on A101 Rotherhithe Tunnel between its junctions with Rotherhithe Roundabout (the roundabout at the junction with Jamaica Road, Lower Road, Brunel Road and Rotherhithe Tunnel) in the London Borough of Southwark and Branch Road in the London Borough of Tower Hamlets;
 - (2) entering, exiting or proceeding on Rotherhithe Tunnel Approach between its junctions with Rotherhithe Tunnel and Commercial Road;
 - (3) entering, exiting or proceeding on Branch Road between its junctions with Commercial Road and Rotherhithe Tunnel. Local access will be maintained to the southern spur of Branch Road and Ratcliffe Lane.The Order will be effective at certain times from 27th June 2021 until 30th October 2021 every night 10:00 PM to 5:00 AM or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibition is in force an alternative route will be indicated by traffic signs via **(for traffic wishing to travel northwards)** A200 Jamaica Road, A200 Tanner Street, A200 Druid Street, A100 Tower Bridge Road, A2 Old Kent Road, New Cross Road, A2 Blackheath Road, A2 Blackheath Hill, A2 Shooters Hill Road, A102 Blackwall Tunnel Southern Approach, A102 Blackwall Tunnel, A13 East India Dock Road and A13 Commercial Road to normal route of travel; **(for traffic wishing to travel southwards)** Commercial Road, East India Dock Road, Brunswick Road, Blackwall Tunnel, Blackwall Tunnel Southern Approach, Shooters Hill Road, Blackheath Hill, Blackheath Road, New Cross Road, Old Kent Road, Bricklayers Arms Roundabout, Tower Bridge Road, Queen Elizabeth Street, Tooley Street and Jamaica Road.
