## Road Traffic Regulation Act 1984

### The Lewisham (Various Roads) (Temporary Prohibition of Traffic) Order 2021

**NOTICE IS HEREBY GIVEN** that Lewisham Council intend to make this temporary traffic order under the provisions of section 14(1) of the Road Traffic Regulation Act 1984 because of works on and adjacent to the highway. The effects of the order will be as indicated below.

**1. (1)** Road closure and no parking/waiting in: – Cowden Street; Ballamore Road, between Pendragon Road and Reigate Road; Beaulieu Avenue; Bousfield Road, between Kitto Road and Arbuthnot Road; Brockley View, between Montem Road and Duncombe Hill; Canonbie Road; Clayhill Crescent, between Marvels Lane and Dunkery Road; Cowden Street; Dacres Road, between Mayow Road and Bampton Road; Dallinger Road, between Holme Lacey Road and No 44 Dallinger Road; Dalmain Road; Drakefell Road, between Wallbutton Road and Pepys Road; Durham Hill, between Capstone Road and Gittens Close; Elsiemaud Road, between Chudleigh Road and Brockley Grove; Fairlie Gardens; Fransfield Grove; Ghent Street; Henryson Road, between Chudleigh Road and Brockley Grove; Holme Lacey Road; Launcelot Road, between Downham Way and Geraint Road; Lescombe Close, southwestern arm (cul-de-sac from Lescombe Road); Manwood Road; Mylis Close; Pendragon Road, between Ballamore Road and Round Table Road; Pendrell Road, between Wallbutton Road and Pepys Road; Pragnell Road, between Coopers Lane and Kingsland Road; Round Hill, between Dartmouth Road and the rear boundary of 106 Dartmouth Road; Stillness Road; between Codrington Hill and Brockley Rise; Tressillian Road, between Montagu Avenue and Harefield Road; Tristram Road, between Lamerock Road and Capstone Road; Trundeleys Road, between Bestwood Street and Alloa Road; Verdant Lane, between Pasture Road and Sandhurst Road; and Woodyates Road. (Note: The prohibitions in article 1 are due to footway resurfacing works.)

(2) Alternative routes for traffic affected by the closures will be via local neighbouring roads and will be signed on the roads during the works if applicable.

**2. (1)** No parking/waiting in the following lengths of Grove Street:- (i) East & northeast side, between the projected boundary of Nos. 16/18 and the projected northwest kerbline of Leeway; (ii) East side, between a point 47 metres north of the projected northern kerbline of Oxestalls Road and a point 22.5 metres northwards thereof; (iii) West side, between a point 27 metres north the projected northern kerbline of Oxestalls Road and a point 42.5 metres northwards thereof; (iv) Both sides, between the projected southern kerbline of Plough Way and a point 38 metres southwards thereof. (Note: The prohibitions in article 2 are to cater for the diversion route required to enable the works on Evelyn Street to be carried out.)

**3.** Exemption will be provided in the order for vehicles engaged on the works, vehicles being used for ambulance, fire brigade or police purposes and anything done with the permission or at the direction of a police officer in uniform.

**4.** The order is intended to come into force on the 15th November 2021 to remain in force for up to 6 months.

(Note: Many of the roads in article 1 may not require closures to traffic, although all of them will have parking restrictions imposed to some extent during the works. Residents and businesses in each street will receive prior written notification with an indication of the extent and duration of works in that street.)

**5.** The prohibitions will apply as, when and to the extent signed on the highway.
