Road Traffic Regulation Act 1984

The Lewisham (Various Roads) (Thames Water)

(Temporary Prohibition of Traffic) Order 2021

NOTICE IS HEREBY GIVEN that Lewisham Council intend to make this temporary traffic order under the provisions of section 14(1) of the Road Traffic Regulation Act 1984 because of Thames Water works on and adjacent to the highway. The effects of the order shall be as indicated below.

1. (1) Road closure and no parking/waiting in Blackheath Rise, between Princes Rise and Oppenheim Road. (2) The diversion routes for traffic affected by the prohibition shall be via Blackheath Rise, Lewisham Hill and Princes Rise, and vice versa.
2. (1) Road closure and no parking/waiting in Brockley Hall Road, between Bearstead Rise and Sevenoaks Road. (2) The diversion routes for traffic affected by the prohibition shall be via Brockley Hall Road, Brockley Grove, Brockley Road and Sevenoaks Road, and vice versa.
3. (1) Road closure and no parking/waiting in Chudleigh Road, between Bexhill Road and Brockley Grove. (2) The diversion routes for traffic affected by the prohibition shall be via either (i) Brockley Grove, Manwood Road and Bexhill Road, and vice versa or (ii) Brockley Grove, Abbotswell Road, Elsiemaud Road and Chudleigh Road, and vice versa.
4. (1) Road closure and no parking/waiting in Ermine Road, between Vicars Hill and Nos.87/89 Ermine Road. (2) The diversion routes for traffic affected by the prohibition shall be via Vicars Hill and Ermine Road, and vice versa.
5. (1) Road closure and no parking/waiting in Foxberry Rd, between Harcourt Rd and Nos. 69/71 Foxberry Rd. (2) The diversion routes for traffic affected by the prohibition shall be via Harcourt Road, Brockley Road and Foxberry Road and vice versa.
6. (1) Road closure and no parking/waiting in Harefield Road, between Harefield Mews and Wickham Road. (2) The diversion routes for traffic affected by the prohibition shall be via either (i) Wickham Road, Brockley Road and Harefield Road, and vice versa, or (ii) Wickham Road, Cranfield Road, Brockley Road and Harefield Road, and vice versa.
7. Exemption will be provided in the order for vehicles engaged on the works, vehicles being used for ambulance, fire brigade or police purposes in an emergency and anything done with the permission or at the direction of a police officer.
8. The order is intended to come into force on the 3rd January 2022 to remain in force for up to 4 months.
(Note: The works are planned to be completed as follow: – Blackheath Rise and Foxberry Road 31st Dec 2021 to 9th January 2022; Brockley Hall Road 9th to 17th February 2022; Chudleigh and Ermine Roads 7th to 14th February 2022; Foxberry Road; Harefield Road 14th to 21st February 2022.)
9. The prohibitions will apply as, when and to the extent signed on the highway.
