## ROAD TRAFFIC REGULATION ACT 1984

### THE A24 GLA ROAD (PRIORY ROAD/ CHRISTCHURCH ROAD/ MERANTUN WAY, LONDON BOROUGH OF MERTON) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2021

1. Transport for London in consultation with the London Borough of Merton hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable highway improvement and resurfacing works to take place on the A24 Priory Road/ Christchurch Road/ Merantun Way.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) entering, exiting, proceeding or stopping on A24 Priory Road/ Christchurch Road between its junctions with Merton High Street/ High Street Colliers Wood and Mertanun Way;
  - (2) entering or proceeding in Christchurch Road southbound between its junctions with High Street Colliers Wood and Colwood Gardens, local access maintained;
  - (3) entering, proceeding or stopping on Christchurch Road between its junctions with Priory Road and Colwood Gardens;
  - (4) entering or proceeding in Christchurch Road between its junctions with Western Road and Merantun Way, local access will be maintain between Western Road and Runnymede;
  - (5) entering, exiting or proceeding on Tandem Way between its junctions with Prince Georges Road and Merantun Way;
  - (6) entering, exiting, proceeding or stopping on Mertantun Way between its junctions with Morden Road and Christchurch Road.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 12:01 AM on 6th November 2021 and 31st March 2022, every night 9:00 PM until 6:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For Priory Road closure (northbound traffic) via High Street Colliers Wood, Tooting High Street, Mitcham Road, London Road, Holborn Way, Western Road and Christchurch Road or reverse to normal route of travel. For Merantun Way/ Prior Road (southbound traffic) via Merton High Street, Abbey Parade, Merton High Street, Morden Road and Merantun Way or reverse to normal route of travel. For Merantum Way via Moden Road, Morden Hall Road, Morden Road, London Road, Lower Green West, London Road, Western Road and Christchurch Road or reverse to normal route of travel.
