Application for Grant of Premises Licence

Summer Events Series Ltd - Time limited premises licence from 1st March 2022 to 30th September 2023 for activities detailed below.

Summer Events Ltd has applied to the London Borough of Lambeth for the grant of a Premises Licence, in respect of the following premises: **Brockwell Park, Dulwich Road, Herne Hill, SE24 9BJ** which would authorise the following licensable activities for up to ten (10) days per annum of which seven (7) may be major events.

Plays, films, indoor sporting events, boxing / wrestling entertainment, live music, recorded music, performances of dance, and anything of similar description to live music, recorded music or performances of dance.

Mon 10:00-22:15, Tue & Wed 10:00-22:00, Thu & Fri 10:00-22:45, Sat & Sun 11:00-22:45.

On a Major Event day the advertised site open time will remain at 12:00, we are applying for a 11:00 site open time as a contingency to deal with a potential build up of early arrivals.

Major Event Days: On Fridays & Saturdays the events will close at 22:45. On Sundays the events will close at 22:15, unless they are followed by a bank holiday or public holiday in which case the closing time on those Sundays will be 22:45.

For 2022 where a bank / public holiday falls on the Thursday and is followed by a bank / public holiday Friday the closing time on the Thursday will be 22:45.

Where a Bank Holiday or Public Holiday is followed by a standard working business day, the closing time will be 22:15.

Minor Event Days: The site opening will be 10:00 and the close time will be 22:00.

Supply of Alcohol

Mon 10:00-22:00, Tue & Wed 10:00-21:45, Thu & Fri 10:00-22:30, Sat & Sun 11:00-22:30.

Major Event Days: On Fridays & Saturdays alcohol will be on sale from 11:00 - 22:30. On Sundays alcohol will be on sale from 11:00 - 22:00, unless they are followed by a bank holiday or public holiday in which case alcohol will be served on those Sundays from 11:00 - 22:30.

For 2022 where a bank / public holiday falls on the Thursday and is followed by a bank / public holiday Friday the alcohol sale times will be 11:00 - 22:30.

Where a Bank Holiday or Public Holiday is followed by a standard working business day, the alcohol service times will be 11:00 - 22:00.

Minor Event Days: The alcohol sales times will be 10:00 - 21:45.

The record of this application may be inspected during normal office hours by an appointment at the Licensing Section, London Borough of Lambeth, 3rd Floor, Civic Centre, 6 Brixton Hill, London, SW2 1EG, or via the licensing authority's website, at www.lambeth.gov.uk/licensing

A responsible authority or any other person may make representation to the licensing authority in respect of this application. Representations must be made in writing, either by post to the above address, or by email to licensing@lambeth.gov.uk and must be received no later than 20/01/2022.

It is an offence to knowingly or recklessly make a false statement in connection with a licensing application, and the maximum fine for which a person is liable on summary conviction for that offence shall not exceed level 5 on the standard scale (£5,000).
