Road Traffic Regulation Act 1984

The Lewisham (Various Roads) (Thames Water) (Temporary Prohibition of Traffic) Order 2022

NOTICE IS HEREBY GIVEN that Lewisham Council intend to make this temporary traffic order under the provisions of section 14(1) of the Road Traffic Regulation Act 1984 because of Thames Water works on and adjacent to the highway. The effects of the order shall be as indicated below.

- 1.** (1) Road closure and no parking/waiting in Blackheath Vale, SE3, the section fronting Nos. 1 to 9 Blackheath Vale; (2) There is no diversion route available for traffic affected by this prohibition. Access will be maintained for residents and businesses as far as practicable.
- 2.** (1) Road closure and no parking/waiting in Crescent Way, SE4 between Tressillian Road and the common boundary of Nos. 29 and 31 Crescent Way. (2) The diversion routes for traffic affected by the prohibition shall be via Tressillian Road, Tressillian Crescent and Crescent Way, and vice versa.
- 3.** (1) Road closure and no parking/waiting in Gellatly Road, SE14 – between Arbuthnot Road and the common boundary of Nos. 27 and 29 Gellatly Rd. (2) The diversion routes for traffic affected by the prohibition shall be via Kitto Road, Erlanger Road and Arbuthnot Road, and vice versa.
- 4.** (1) Road closure and no parking/waiting in Laleham Road, SE6 between Elmer Road and Sportsbank Street. (2) The diversion routes for traffic affected by the prohibition shall be via Elmer Road, Shorndean Street and Sportsbank Street, and vice versa.
- 5.** (1) Road closure and no parking/waiting in Vicars Hill, SE13 between Ermine Road and Embleton Road. (2) The diversion routes for traffic affected by the prohibition shall be via Ermine Road, Ellerdale Street and Embleton Road, and vice versa.
- 6.** (1) Road closure and no parking/waiting in Wallbutton Road, SE4 between Drakefell Road and Pendrell Road. (2) The diversion routes for traffic affected by the prohibition shall be via either (i) Pendrell Road, Pepys Road, Vesta Road, Endwell Road and Drakefell Road; or (ii) Drakefell Road, Sprules Road, Vesta Road and Wallbutton Road.
- 7.** Exemption will be provided in the order for vehicles engaged on the works, vehicles being used for ambulance, fire brigade or police purposes in an emergency and anything done with the permission or at the direction of a police officer.
- 8.** The order is intended to come into force on the 2nd February 2022 to remain in force for up to 4 months.

(Note: The work at each site is planned to last approximately 5 to 7 days and to start on the following dates:-Blackheath Vale 4th April; Crescent Way 15th February; Gellatly Road 21st March; Laleham Road 28th March; Vicars Hill 30th March; and Wallbutton Road 2nd February.)

- 9.** The prohibitions will apply as, when and to the extent signed on the highway.
