THE A3220 GLA ROAD (WARWICK ROAD/ FINBOROUGH ROAD) AND A4 GLA ROAD (WEST CROMWELL ROAD, ROYAL BOROUGH OF KENSINGTON AND CHELSEA) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2022

- Transport for London in consultation with the Royal Borough of Kensington and Chelsea hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.

 The purpose of the Order is to enable highway improvement and resurfacing works to take place on the A3220 Warwick Road/
- Finborough Road and A4 West Cromwell Road.

 3. The effect of the Order will be to prohibit any vehicle from:
- entering or proceeding on Warwick Road northbound at its junction with West Cromwell Road;
 - (2) turning right from West Cromwell Road into Warwick Road northbound;
 - (3) entering or proceeding on Old Brompton Road between its junctions with Redcliffe Gardens and Kramer Mews, local access will be maintained between Redcliffe Gardens and Coleherne Road;
 - (4) stopping on Old Brompton Road between its junctions with Coleherne Road and Kramer Mews;
 - (5) entering, proceeding or stopping on Warwick Road between its junctions with Old Brompton Road and Penywern Road;
 - junctions with Old Brompton Road and Penywern Road;
 (6) entering or proceeding on Finborough Road between its junctions with Fulham Road and Old Brompton Road, local access will be
 - maintain between Fulham Road and Wharfdale Street;

 (7) stopping on Finborough Road between its junctions with Old Brompton Road and Wharfdale Street.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 14th February

2022 and 7th July 2022, every night 9:00 PM until 6:00 AM or when the

works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- 4. The prohibitions will not apply in respect of:(1) any vehicle being used for the purposes of those works or for fire
- brigade, ambulance or police purposes;
 (2) anything done with the permission or at the direction of a police
 - constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For Cromwell Road closure via West Cromwell Road, Talgarth Road, Queen Caroline Street, Hammersmith Road, Butterwick, Talgarth Road, West Cromwell Road to normal route of travel. For Finborough closure via Fulham Road, Fulham Broadway, Dawes Road, Lillie Road, Fulham Palace Road, Queen Caroline Street, Hammersmith Road, Butterwick, Talgarth Road and West Cromwell
