near Isabella Street will be extended and the business / pay by phone parking bay will be changed to a shared use permit holders bay. 1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth on 23rd February 2022 have made the Lambeth (Waterloo "W") (Parking Places) (No. -)

Order 2022, the Lambeth (Waiting and Loading Restriction) (Amendment No. -) Order 2022, the Lambeth (Loading Place) (No. -) Order 2022, the Lambeth (Free Parking Places) (Disabled Persons) (No. -) Order 2022, under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders will be, in Hatfields to:-(a) remove the existing shared use parking place and disabled persons' parking place on the west side of Hatfields outside Nos. 1 to 10 Benson House and replace with "at any time" waiting and loading restrictions:

(b) reduce the existing loading bay on the west side of Hatfields outside unit Nos. 2 to 3 Benson House and

- replace with "at any time" waiting and loading restrictions; (c) extend the existing shared use parking places on the west side of Hatfields outside Nos. 11 to 20 Benson House so that they will be one continuous parking
- place; and (d) amend the type of permit holders parking place on the west side of Hatfields north of Isabella Street from business permit and pay by phone to shared
