LONDON BOROUGH OF LAMBETH ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14 TEMPORARY CLOSURE OF ATKINS ROAD, CLARENCE AVENUE AND WEIR ROAD

NOTICE IS HEREBY GIVEN that, to enable maintenance and repair works to be carried out by Thames Water, the Council of the London Borough of Lambeth intend to make

- an Order the effect of which would be to temporarily ban vehicles from entering the following lengths of roads:

 (a) that length of Atkins Road which comprises the roundabout situated at its junction with Clarence Avenue. Thornton Road and Weir Road, which lies
 - Avenue, Thornton Road and Weir Road, which lies between the south-eastern side of the pedestrian island situated at the junction of Clarence Avenue and the eastern side of the pedestrian island situated at the junction of Weir Road;

 (b) that length of the westbound carriageway of the
 - western arm of Atkins Road, which lies between the south-western kerb-line of Atkins Road roundabout and a point 12 metres west of that kerbline; (c) that length of the northbound carriageway of Clarence Avenue, which lies between the
 - northeastern kerb-line of Atkins Road roundabout and a point 13 metres north of that kerb-line; (d) that length of the north-eastbound carriageway of Weir Road, which lies between the western kerb-line

of Atkins Road roundabout and a point 15 metres

- south-west of that kerb-line.

 2. It is anticipated that the restrictions referred to in paragraph 1 above would be carried out in 2 phases as follows (a) Phase 1 that part of Atkins Road roundabout between the eastern carriageway of the western arm of Atkins Road and Weir Road, including the lengths of road specified in subparagraphs 1(b) and 1(d) above. The
- specified in subparagraphs 1(b) and 1(d) above. The alternative route for affected vehicles will be via Cavendish Road, Clapham Common South Side, The Avenue, Cavendish Road, Poynders Road and Clarence Avenue; and (b) Phase 2 that part of Atkins Road roundabout between the western carriageway of the western arm of Atkins Road and Clarence Avenue, including the length of road specified in sub-paragraph 1(c) above. The alternative route for affected vehicles will be via Weir Road and Cavendish Road.

 3. The road closures would only apply at such times and to
- The road closures would only apply at such times and to such extent as shall be indicated by the placing of the appropriate traffic signs.
- 4. The Order would come into force on 4th April 2022 and would continue for a maximum duration of 6 months or until the works have been completed, whichever is the sooner. In practice it is anticipated that the works would be carried out between 4th April 2022 and 20th April 2022, but if the works cannot be carried out or completed during this time then the Order may have effect at a subsequent time within the maximum period of 6 months.
