SALTOUN ROAD 1. NOTICE IS HEREBY GIVEN that to enable collaborative works to be carried out by Lambeth Council's Highways Maintenance Improvement Team and Utility Companies, the

DALBERG ROAD, JELF ROAD, KELLETT ROAD, RATTRAY ROAD AND

- Council of the London Borough of Lambeth, subject to the agreement of Transport for London intend to make an Order the effect of which would be to temporarily:-(a) ban vehicles from entering or waiting (including waiting for the purpose of loading
- or unloading a vehicle) in that length of:-(i) Atlantic Road which lies between Coldharbour Lane and Kellet Road (including
  - the parking places);
    - (ii) Dalberg Road, which lies between the party wall of Nos. 49 and 51 Dalberg Road and the party wall of Nos. 91 and 93 Dalberg Road (including the parking places); (iii) Jelf Road, which lies between Dalberg Road and a point 12 metres south-west
  - of Rattray Road: and at certain other times in that length of Jelf Road which lies between a point 12 metres south-west of Dalberg Road and Talma Road (including the parking places);
  - (iv) Rattray Road, which lies between the party wall of Nos. 90 and 92 Rattray Road and Probert Road (including the parking places):
  - (b) ban vehicles from waiting (including waiting for the purpose of loading or unloading a vehicle) in that length of:-
    - (i) Atlantic Road which lies between Vining Street and Kellet Road (including the
    - parking places); (ii) Saltoun Road, which lies on the south-east side, between Effra Road and the southwestern wall of No. 2b Saltoun Road (including the car club parking place
  - on the south-east side of Saltoun Road): (c) impose a one-way system in:-

    - (i) Saltoun Road in a north-easterly direction (towards Atlantic Road);
    - (ii) Kellett Road in a south-westerly direction (towards Effra Road);
    - (iii) that length of Atlantic Road which lies between Coldharbour Lane and Vining

Street in a north-westerly direction (towards Coldharbour Lane):

- (d) ban vehicles proceeding in a north-westerly direction in Rattray Road from turning
- left into Saltoun Road: (e) ban vehicles proceeding in a north-westerly direction in Rattray Road from turning
- right into Kellett Road: (f) ban vehicles proceeding in a south-easterly direction in Rattray Road from turning
- left into Kellett Road:
- (g) suspend the ban on buses proceeding in a south-easterly direction in that length of Atlantic Road which lies between Brixton Road and Coldharbour Lane from turning right into Coldharbour Lane (all other vehicles would continue to be banned from turning right).
- 2. Alternative routes would be available for vehicles affected by the bans described in paragraph 1 above, via adjacent streets as indicated by traffic signs. 3. The bans and suspension would only apply at such times and to such extent as shall
- be indicated by the placing of the appropriate traffic signs. 4. The Order would come into force on 14th March 2022 and continue for a maximum duration of 18 months (to allow for contingencies) or until the works have been completed,
- whichever is the sooner. Dated 4th March 2022
