Palace Road) Order 2022. 2. The proposed Order would authorise the stopping-up of an area of the footway on the west side of Lambeth Palace Road (outside No. 163 Lambeth Palace Road, Prideaux Building (King's College London, St Thomas' Campus). The area to be stopped-up is shown on the plan attached to the proposed Order (the "relevant plan").

3. If the proposed Order is made, the stopping-up of highway would be authorised only to enable the development described in the Schedule to this Notice to be carried out, in accordance with the planning permission granted on 13th April 2021 under reference 20/00884/FUI 4.
