The Lewisham (Creekside, SE8 and Sydenham Park, SE26) (Temporary Prohibition of Traffic) Order 2022 NOTICE IS HEREBY GIVEN that Lewisham Council made the above named temporary traffic Order under the provisions of section 14(1) of the Road

temporary traffic Order under the provisions of section 14(1) of the Road Traffic Regulation Act 1984 because of regeneration works on and adjacent to the highway. The effects of the Order are indicated below. 1. (1) Road closure and no parking/waiting in (ii) Creekside. SE8 between

- 1. (1) Hoda closure and no parking/walling in (1) creekside, SES between Deptford Church Street and 79/81 Creekside; (ii) Bronze Street, SES; (iii) Berthon Street, SES; and (iv) Copperas Street, SEB. (2) The alternative routes for traffic affected by the prohibition shall be, as applicable, via Creekside, Deptford Church Street, Creek Road and Creekside, and vice versa.

 (Note: Works in Creekside and surrounds are planned to continue until
- (Note: Works in Creekside and surrounds are planned to continue until September 2022. Access to off-street parking areas, Bronze Street, Berthon Street and Copperas Street, will generally be maintained during the works.)

 2. (1) Peed decays (including for pedestrians) and no parking furniting.
- 2. (1) Road closure (including for pedestrians) and no parking/waiting in (i) Sydenham Park, between Longfield Crescent and the eastern extents of Sydenham Park, (ii) the footpath between Sydenham Park and Dacres Road; and (iii) the footpath between Sydenham Park and Clyde Vale. (2) The diversions, where applicable, shall be via surrounding roads and footpaths. (Note: The works at Sydenham Park footbridge are planned to take place
- from late June until October, although this is dependent on Network Rail track possessions. Access for pedestrians will be maintained for the bulk of the duration and only prohibited when overhead operations are ongoing.)

 3. No parking in (i) Sydenham Park between Longfield Crescent and Kirkdale; and (ii) Sydenham Park Road between Dartmouth Road and
- 49/51 Sydenham Park Road.

 (Note: Parking prohibitions in article 3 above will only be in effect to allow access for a mobile crane over one weekend, the dates of which are yet to be determined. Further details will be circulated to all affected properties
- 4. Exemption is provided in the Order for persons and vehicles engaged on the works, vehicles being used for ambulance, fire brigade or police purposes and anything done with the permission or at the direction of a police officer in uniform.
- 5. The Order comes into force on the 28th March 2022 to remain in force for up to 9 months.
- The prohibitions will apply as, when and to the extent signed on the highway.
