THE A3220 GLA ROAD (ASHBURNHAM ROAD / CREMORNE ROAD / CHEYNE WALK, ROYAL BOROUGH OF KENSINGTON AND CHELSEA) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2022

- Transport for London in consultation with the Royal Borough of Kensington and Chelsea hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.

 2. The purpose of the Order is to enable highway improvement and resurfacing works to take place on the A3220 Ashburnham Road / Cremorne Road / Cheyne Walk.
- entering, exiting, proceeding or stopping on A3220 Ashburnham Road / Cremorne Road / Cheyne Walk between its junctions with Kings Road and Battersea Bridge/ Beaufort Street;

3. The effect of the Order will be to prohibit any vehicle from:

- (2) entering or proceeding on Edith Grove between its junctions with Kings Road and Cremorne Road, local access will be maintained;
- (3) entering or proceeding on A3212 Chelsea Embankment / Cheyne Walk westbound between its junction with Albert Bridge and Battersea Bridge, local access will be maintained;

The Order will also:

- (4) permit two-way operation on Milman's Street between its junctions with Ann Lane and Cheyne Walk;
- (5) permit two-way operation on Edith Grove between its junctions with Kings Road and Cremorne Road.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective between 31st March 2022 and 7th July

2022, every night from 9:00 PM until 6:00 AM or when the works have

been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- 4. The prohibitions will not apply in respect of:
 - any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For closure of Edith Grove via Kings Road and Beaufort Street to normal route of travel. For closure of Cheyne Walk via Battersea Bridge, Battersea Bridge Road, Parkgate Road, Albert Bridge Road, Albert Bridge, Oakley Street and Kings Road to normal
