ROAD TRAFFIC REGULATION ACT 1984

THE GLA ROADS (VARIOUS ROADS, CITY OF WESTMINSTER) (TEMPORARY PROHIBITION OF TRAFFIC, STOPPING AND SUSPENSION OF BUS LANES) ORDER 2022

1. Transport for London hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable highway lining and signage works to take place on various GLA roads in the City of Westminster.
3. The effect of the Order will be to prohibit any vehicle from stopping on the:
 - (1) A41 GLA Road – Finchley Road, Wellington Road, Park Road, Baker Street, Gloucester Place, Dorset Square between its junctions with Boundary Road and Marylebone Road;
 - (2) A5205 GLA Road – St John's Wood between its junctions with Maida Vale and Park Road;
 - (3) A501 GLA Road – Marylebone Road, Euston Road, Old Marylebone Road, Marylebone Flyover between its junctions with Westway and Euston Road;
 - (4) A5 GLA Road – Maida Vale, Edgware Road between its junctions with St John's Wood Road and Old Marylebone Road;
 - (5) A40 GLA Road – Marble Arch, Cumberland Gate, Park Lane, Tyburn Way between its junctions with Bayswater Road, Edgware Road and Oxford Street;
 - (6) A4202 GLA Road – Park Lane between its junctions with Cumberland Gate and Hyde Park Corner;
 - (7) A4 GLA Road – Knightsbridge, Hyde Park Corner, Piccadilly, Duke of Wellington Place, Grosvenor Place between its junctions with Piccadilly Underpass and the Borough boundary between Kensington & Chelsea and Westminster;
 - (8) A302 GLA Road – Grosvenor Place, Grosvenor Gardens, Victoria Street between its junctions with Hyde Park Corner and Bressenden Place;
 - (9) A3217 GLA Road – Lower Grosvenor Place, Bressenden Place between its junctions with Grosvenor Place and Victoria Street;
 - (10) A3213 GLA Road – Eccleston Bridge between its junctions with Belgrave Road and Buckingham Palace Road;
 - (11) Bridge Place between its junctions with Wilton Road and Eccleston Bridge;
 - (12) A3214 GLA Road – Grosvenor Gardens, Buckingham Palace Road between its junctions with Eccleston Bridge and Lower Grosvenor Place;
 - (13) A202 GLA Road – Wilton Road, Neathouse Place, Vauxhall Bridge Road, Bessborough Gardens, Vauxhall Bridge between its junctions with the Borough boundary between Westminster and Lambeth at the centre of Vauxhall Bridge to its junction with Victoria Street;

The Order will be to prohibit any vehicle from:

- (14) entering or proceeding on the westbound slip road between its junctions with Marylebone Flyover and Harrow Road;
- (15) entering or proceeding on the eastbound slip road between its junctions with Harrow Road and Marylebone Flyover;

The Order will also permit all vehicles to use all the bus lanes on the:

- (16) A41 GLA Road – Finchley Road, Wellington Road, Park Road, Baker Street, Gloucester Place, Dorset Square between its junctions with Boundary Road and Marylebone Road;
- (17) A5205 GLA Road – St John's Wood between its junctions with Maida Vale and Park Road;
- (18) A501 GLA Road – Marylebone Road, Euston Road, Old Marylebone Road, Marylebone Flyover between its junctions with Westway and Euston Road;
- (19) A5 GLA Road – Maida Vale, Edgware Road between its junctions with St John's Wood Road and Old Marylebone Road;
- (20) A40 GLA Road – Marble Arch, Cumberland Gate, Park Lane, Tyburn Way between its junctions with Bayswater Road, Edgware Road and Oxford Street;
- (21) A4202 GLA Road – Park Lane between its junctions with Cumberland Gate and Hyde Park Corner;
- (22) A4 GLA Road – Knightsbridge, Hyde Park Corner, Piccadilly, Duke of Wellington Place, Grosvenor Place between its junctions with Piccadilly Underpass and the Borough boundary between Kensington & Chelsea and Westminster;
- (23) A302 GLA Road – Grosvenor Place, Grosvenor Gardens, Victoria Street between its junctions with Hyde Park Corner and Bressenden Place;
- (24) A3217 GLA Road – Lower Grosvenor Place, Bressenden Place between its junctions with Grosvenor Place and Victoria Street;
- (25) A3213 GLA Road – Eccleston Bridge between its junctions with Belgrave Road and Buckingham Palace Road;
- (26) Bridge Place between its junctions with Wilton Road and Eccleston Bridge;
- (27) A3214 GLA Road – Grosvenor Gardens, Buckingham Palace Road between its junctions with Eccleston Bridge and Lower Grosvenor Place;
- (28) A202 GLA Road – Wilton Road, Neathouse Place, Vauxhall Bridge Road, Bessborough Gardens, Vauxhall Bridge between its junctions with the Borough boundary between Westminster and Lambeth at the centre of Vauxhall Bridge to its junction with Victoria Street.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 10:00 PM on 18th March 2022 until 5:00 AM on 18th May 2022 or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force an alternative route will be indicated by traffic signs via Westway, Westway Roundabout, West Cross Route, Holland Park Roundabout, Holland Park Avenue, Notting Hill Gate, Pembridge Road, Pembridge Villas, Westbourne Grove, Bishop's Bridge Road, Harrow Road, North Wharf Road and Harrow Road to normal route of travel.
