- Transport for London, have made an Order the effect of which will be to temporarily: (a) in Mandalay Road, ban vehicles from travelling in a north-westerly direction,
 - between the north-western kerb-line of Klea Avenue and the south-eastern kerbline of Hambalt Road:
 - (b) in Narbonne Avenue, ban vehicles from travelling in a south-easterly direction, between the south-eastern kerb-line of Clapham Common South Side and its
 - junction with Hambalt Road: (c) in Cautley Avenue, ban vehicles from travelling in a south-easterly direction, between the south-eastern kerb-line of Clapham Common South Side and between
 - the north-western kerb-line of Klea Avenue:
 - (d) in Klea Avenue, ban vehicles from: travelling in a south-westerly direction, between the south-western kerb-line of
 - Narbonne Avenue and the north-eastern kerb-line of Shandon Road: entering that section which lies between the south-western kerb-line of Shandon
 - Road and the north-eastern kerb-line of Cautley Avenue; (iii) travelling in a south-westerly direction, between the south-western kerb-line of
 - Cautley Avenue and the north-eastern kerb-line of Lessar Avenue: (iv) travelling in a south-westerly direction, between the south-western kerb-line of
 - Lessar Avenue and the north-eastern kerb-line of Lynette Avenue:
 - (v) travelling in a south-westerly direction, between the south-western kerb-line of
 - Lynette Avenue and the north-eastern kerb-line of Cavendish Road: (e) in Shandon Road, ban vehicles from entering that section which lies between the north-western kerb-line of Abbeville Road and the south-eastern kerb-line of Klea
 - (f) in Lessar Avenue, ban vehicles from travelling in a north-westerly direction, between the north-western kerb-line of Klea Avenue and the south-eastern kerb-line of Clapham Common South Side:
 - (g) in Bonneville Gardens, ban vehicles from travelling in a north-westerly direction, between the north-western kerb-line of Elm's Crescent and the south-western kerbline of Abbeville Road:

- 2 Alternative routes for affected vehicles will be available:
 - (a) for 1(a) above via Klea Avenue and Hambalt Road:
 - (b) for 1(b) above via Clapham Common South Side, Cautley Avenue and Klea Avenue;
 - (c) for 1(c) above via Clapham Common South Side, Lessar Avenue and Klea Avenue: (d) for 1(d) above via (i) Narbonne Avenue, Abbeville Road and Shandon Road; (ii) Cautley Avenue, Clapham Common South Side and Narobonne Avenue, and

Shandon Road, Abbeville Road, Narbonne Avenue, Clapham Common South Side

- and Cautley Avenue; (iii) Cautley Avenue, Clapham Common South Side and Lessar Avenue: (iv) Lessar Avenue. Clapham Common South Side and Lynette Avenue: and (v) Lynette Avenue, Clapham Common South Side and Cavendish Road; (e) for 1(e) above via Abbeville Road. Narbonne Avenue and Klea Avenue (both
- directions): (f) for 1(f) above via Klea Avenue, Cautley Avenue and Clapham Common South Side;
- and
- (g) for 1(g) above via Elm's Crescent, Shandon Road and Abbeville Road.
- 3. The bans will only apply at such times and to such extent as shall be indicated by the
- placing of the appropriate traffic signs. 4. The Order will come into force on 15th June 2022 and will continue for a maximum duration of 18 months (to allow for contingencies) or until the works have been completed whichever is the earlier. In practice it is anticipated that the works will be undertaken in 1

/ 2 street units at any time and each street unit will be carried out in short phases of 3 - 5
