- I. Transport for London, hereby gives notice that it intends to make the above named Orders under section 6 of the Road Traffic Regulation Act
- 2. The general nature and effect of the Orders will be to:

- (I) formalise the introduction of a no Stopping at Any Time restriction (Double Red Lines) at the north-eastern side of Savona Street between its junction with Battersea Park Road and a point opposite
- the southern building line of No.101 Battersea Park Road; (2)
 - formalise the removal of the Parking at Any Time bay at the northeastern kerb of Savona Street and its replacement with the No Stopping at Any Time restriction above; (3) formalise the shortening of the Monday to Saturday 7am to 7pm loading 20 mins and disabled persons' vehicles 3 hours bay on
 - No Stopping at Any Time restriction (Double Red Lines) has been introduced at its previous position; formalise the introduction of an at any time loading 20 mins and disabled persons vehicles 3 hours bay on the eastbound carriageway of Battersea Park Road outside Battersea Power Station

Savona Street at the side of No. 101 Battersea Park Road from 17 metres to 10 metres and move it 12 metres south-eastwards. A

- underground station; formalise the introduction of an at any time loading taxi only bay on the eastbound carriageway of Battersea Park Road outside Battersea Power Station underground station; (6)
- formalise the introduction of wide red line restriction (no stopping at any time including taxis) at the bus stops outside and opposite Viridian Apartments, No. 75 Battersea Park Road; (7) formalise the No Motor Vehicle restriction on Thessally Road
- between its junction with Battersea Park Road and a point 12 metres southwards; (8)
- formalise the removal of the eastbound bus lane on Battersea Park Road between its junctions with Savona Street and Sleaford Street. (9) formalise the shortening of the westbound bus lane on Battersea
- Park Road between its junction Sleaford Street and a point opposite Battersea Dogs and Cats Home by 160 metres at its eastern end. (10) make administrative changes to the description of the no stopping
- at any time restriction (Double Red Lines) at the southern side of the unnamed service road fronting Nos.101 to 125 Battersea Park Road. 3. The road which would be affected by the Orders are Battersea Park
- Road, Savona Street, Thessaly Road and the unnamed service road fronting Nos. 101 to 125 Battersea Park Road. 4.
