ROAD TRAFFIC REGULATION ACT 1984 THE A3 GLA ROAD AND SIDE ROAD (BOROUGH HIGH STREET.

LONDON BRIDGE, KING WILLIAM STREET AND ARTHUR STREET,
CITY OF LONDON AND THE LONDON BOROUGH OF SOUTHWARK)
(TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2022

- 1. Transport for London having consulted the City of London, hereby gives notice that it has made the above-named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- The purpose of the Order is to enable gantry and materials silo removal works to take place at the A3 King William Street and Arthur Street.
- 3. The effect of the Order will be to prohibit any:

 (1) vehicle from entering eviting or proceeding in a portherly direction.
- (1) vehicle from entering, exiting or proceeding in a northerly direction on the A3 Borough High Street, London Bridge and King William Street between its junctions with Duke Street Hill and Cannon
- Street between its junctions with Duke Street Hill and Cannon Street/Eastcheap;

 (2) pedestrian from proceeding on the western footway of the A3 London Bridge and King William Street between its junctions with

Duke Street Hill and Cannon Street. Access to premises will be

maintained;
(3) pedestrian from proceeding on the northern footway of Arthur Street between its junctions with Martin Lane and King William Street.

The Order will be effective at certain times between the dates of 17th

June 2022 and 27th June 2022, 29th July 2022 and 1st August 2022,

- 12th August 2022 and 22nd August 2022 every Friday at 10:00 PM until Monday at 5:00 AM or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- 4. The prohibitions will not apply in respect of:
 - (I) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for
- London.

 5. At such times as the prohibition is in force an alternative route will be indicated by traffic signs via (for the closure London Bridge) (for motor vehicles) Southwark Street, Blackfriars Road northbound, Blackfriars Bridge, New Bridge Street, Queen Victoria Street and Cannon Street to normal route of travel. (for cycles) Southwark Street, Southwark Bridge Road, Northbound, Southwark Bridge, Queen's Street Place and Upper Thames Street eastbound to normal route of travel, (for pedestrians) the eastern footway of London Bridge using the existing pedestrian crossing points at its junctions Duke Street Hill and Cannon Street/Eastcheap.

(for the closure of the Arthur Street footway) King William Street, Cannon Street and Martin Lane or the reverse to normal route of travel.
