73 Wellfield Road Lambeth London SW16 2BT Erection of 2 rear 'linked' dormers extension and the installation of 1 front roof light. 22/02058/FUL

170 Rosendale Road Lambeth London SE21 8LG Installation of a white painted timber sash double glazed window to the rear at first floor level and 1 additional roof light to the front of the elevation. 22/02057/FUL

11-13 Lloyds Bank Clapham Common South Side Lambeth London SW4 7AD Replacement of existing external signage, repair and repainting of corbels and fascia to window frontage. Repair and repair stall riser and window frames in grey. 22/02167/LB

1 - 4 Brixton Hill Place London SW2 1HJ Demolition of the existing buildings and redevelopment of site to provide a H shaped building ranging from 2 - 5 storeys in height comprising 24 self-contained units, together with the provision of 3 disabled car parking bays, refuse and cycle storage, child play area, landscaping and boundary treatment. 22/01987/FUL
