ROAD TRAFFIC REGULATION ACT 1984

THE A202 GLA ROAD (VAUXHALL BRIDGE ROAD, CITY OF WESTMINSTER) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2022

- I. Transport for London in consultation with the City of Westminster hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2.
- The effect of the Order is summarised in paragraph 3. 2. The purpose of the Order is to enable highway improvement and
- resurfacing works to take place on the A202 Vauxhall Bridge Road. 3. The effect of the Order will be to prohibit any vehicle from:
- (I) entering, exiting, proceeding or stopping on the Vauxhall Bridge Road southbound between its junctions with Victoria Street/ Wilton Road and Rampayne Street;
 - (2) entering, exiting, proceeding or stopping on Vauxhall Bridge Road northbound between its junctions with Drummond Gate and Neathouse Place:
 - (3) entering, exiting, proceeding or stopping on Neathouse Place between its junctions with Vauxhall Bridge Road and Wilton Road;
 - (4) entering, exiting, proceeding or stopping on Wilton Road between its junctions with Gillingham Street and Neathouse Place;
 - (5) entering, exiting, proceeding or stopping on Bridge Place between its junctions with Belgrave Road and Neathouse Place; (6) entering, exiting, proceeding or stopping on Warwick Way between
 - its junctions with Upper Tachbrook Street and Vauxhall Bridge Road; (7) entering, exiting, proceeding or stopping on Upper Tachbrook Street
 - between its junctions with Warwick Way and Vauxhall Bridge Road; entering, exiting, proceeding or stopping on Gillingham Street between its junctions with Wilton Road and Vauxhall Bridge Road,
 - local access will be maintained; (9) entering, exiting, proceeding or stopping on A3213 Bessborough Street/Drummond Gate north-eastbound between its junctions with
- Rampayne Street and Vauxhall Bridge Road; The Order will also:

(10) suspend the northbound and southbound bus lanes on Vauxhall

- Bridge Road between its junctions with Millbank/ Grosvenor Road and Wilton Road/Victoria Street; (II) permit two-way operation on Chapter Street between Douglas
- Street and Vauxhall Bridge Road; (12) permit two-way operation on Stanford Street between Vincent
- Square and Vauxhall Bridge Road; (13) permit two-way operation on Udall Street between Vincent Square
- and Vauxhall Bridge Road; (14) permit two-way operation on Francis Street between Carlisle Place
- and Vauxhall Bridge Road. Works will be phased such that some restrictions will apply only at certain
- times. The Order will be effective at certain times between 7 th August 2022 and
- 4 th February 2023, every night 9:00 PM until 6:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- 4. The prohibitions will not apply in respect of:
 - (I) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For Victoria via Millbank, Abingdon Street, Old Palace Yard, St Margaret Street, Parliament Square, Broad Sanctuary and Victoria Street to normal route of travel. Or via Grosvenor Road, Chelsea Bridge Road, Lower Sloane Street, Sloane Square, Cliveden Place, Eaton Gate, Eaton Square, Hobart Place, Lower Grosvenor Place and Bressenden Place to normal route of travel. For Vauxhall Bridge via

Victoria Street, Grosvenor Gardens, Hobart Place, Easton Square, Eaton Gate, Cliveden Place, Sloane Square, Lower Sloane Street, Chelsea

Bridge Road and Grosvenor Road to normal route of travel. Dated this 22 nd day of July 2022
