- I. Transport for London in consultation with the London Borough of Southwark hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is
- 2. The purpose of the Order is to enable highway improvement and resurfacing works to take place on the A201 New Kent Road.
- 3. The effect of the Order will be to prohibit any vehicle from:
- (I) entering, exiting or proceeding on New Kent Road eastbound
- between its junctions with Newington Causeway and Meadow Row; (2) entering, exiting or proceeding on New Kent Road westbound
 - between its junctions with Old Kent Road and Newington Causeway, local access will be maintained between Newington Causeway and
 - Balfour Street: (3) entering, proceeding or stopping on New Kent Road slip road between Bricklayers Arms and New Kent Road;
 - (4) entering or proceeding on Elephant Road between its junctions with
 - Walworth Road and New Kent Road, local access will be maintained: (5) stopping on New Kent Road between its junctions with Newington

- Causeway and Meadow Row; The Order will also: (6) allow all vehicles to use the westbound bus lanes on New Kent Road
- between its junctions with Rodney Place and Newington Causeway;

(7) suspend the cycle lanes on southern footway of New Kent Road

- between Elephant Road and Meadow Row; (8) allow pedals cycles and pedestrians to use the southern footway of
- New Kent Road between Elephant Road and Meadow Row; (9) allow two-way operation on Elephant Road between its junctions
- with Walworth Road and New Kent Road. Works will be phased such that some restrictions will apply only at
- certain times. The Order will be effective at certain times from 7:00 AM on 24th
- August 2022 and 7:00 PM on 8th December 2022 or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to

5. At such times as the prohibitions are in force an alternative route will be

- time be indicated by traffic signs. 4. The prohibitions will not apply in respect of:
 - (I) any vehicle being used for the purposes of those works or for fire
 - brigade, ambulance or police purposes;
 - constable in uniform or a person authorised by Transport for London.
 - indicated by traffic signs via Bricklayers Arms, Great Dover Street, Borough High Street and Newington Causeway or reverse to normal route of travel.
