ROAD TRAFFIC REGULATION ACT 1984

THE A2 GLA ROAD (NEW CROSS ROAD/ DEPTFORD BROADWAY, LONDON BOROUGH OF LEWISHAM) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2022

1. Transport for London in consultation with the London Borough of Lewisham hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable highway improvement and resurfacing works to take place on the A2 New Cross Road/ Deptford Broadway.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering, exiting or proceeding in an easterly direction on A2 New Cross Road between its junctions with Amersham Vale and Florence Road;
 - (2) entering, exiting or proceeding in a westerly direction on A2 New Cross Road/ Deptford Broadway between its junctions with Deptford Church Street and Amersham Road;
 - (3) stopping on A2 New Cross Road/ Deptford Broadway between its junctions with Lewisham Way and Deptford Church Street;
 - (4) entering, exiting or proceeding on Alpha Road between its junction with New Cross Road and Florence Road, local access will be maintained between Florence Road and No.2 Alpha Road;
 - (5) stopping on Alpha Road between its junction with New Cross Road and No.2 Alpha Road;
 - (6) entering or proceeding on Harton Street between its junctions with Vanguard Street and Deptford Broadway, local access will be maintained via Vanguard Street;
 - (7) stopping on Harton Street between its junctions with Deptford Bridge and Vanguard Street;
 - (8) entering or proceeding on Florence Road between its junctions with New Cross Road and Heald Street, local access will be maintained between Heald Street and No.1b Florence Road;
 - (9) stopping on Florence Road between its junction with New Cross Road and No.1b Florence Road;
 - (10) entering, exiting, proceeding or stopping on Wilshaw Street between its junctions with New Cross Road and Pearson's Avenue;
 - (11) entering, exiting, proceeding or stopping on Pearson's Avenue between its junctions with Wilshaw Street and Tanner's Hill;
 - (12) stopping on Vanguard Street between its junctions with Tanner's Hill and Harton Street;
 - (13) entering or proceeding in a southerly direction on Watson's Street between its junctions with Comet Street and New Cross Road, local access will be maintained between Comet Street and No.1b Watson's Street;
 - (14) stopping on Watson's Street between its junction with New Cross Road and No.1 Watson's Street;
 - (15) entering or proceeding on Deptford High Street between its junctions with Hale Street and New Cross Road, local access will be maintained between Hale Street and No.4 Deptford High Street;
 - (16) stopping on Deptford High Street between its junctions with Hale Street and New Cross Road;
 - (17) entering or proceeding on Mornington Road between its junctions with Stanley Street and New Cross Road, local access will be maintained between Stanley Street and the extended northern building line of No.431 New Cross Road;
 - (18) stopping on Mornington Road between its junctions with New Cross Road and the extended northern building line of No.431 New Cross Road;
 - (19) stopping on Stanley Street between its junctions with Douglas Way and Mornington Road;The Order will also:
 - (20) permit all vehicles to use the eastbound and westbound bus lanes on A2 New Cross Road/ Deptford Broadway between its junctions with Lewisham Way and Deptford Church Street;
 - (21) allow two-way operation on Douglas Way between its junctions with Amersham Vale and Stanley Street;
 - (22) allow two-way operation on Stanley Street between its junctions with Douglas Way and Mornington Road;
 - (23) allow two-way operation on Wilshaw Street between its junctions with New Cross Road and Pearson's Avenue;
 - (24) allow two-way operation on Tanner's Hill between its junctions with New Cross Road and Vanguard Street;
 - (25) allow two-way operation on Pearson's Avenue between its junctions with Wilshaw Street and Tanner's Hill;
 - (26) allow two-way operation on Vanguard Street between its junctions with Tanner's Hill and Harton Street;
 - (27) allow two-way operation on Deptford High Street between its junctions with Hale Street and New Cross Road;
 - (28) allow two-way operation on Harton Street between its junctions with Deptford Broadway and Vanguard Street.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 23rd October 2022 and 23rd April 2023, every night 9:00 PM until 5:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. Westbound traffic via Blackheath Road, Blackheath Hill, Shooters Hill Road, Sun in the Sands Roundabout, A2 southbound on-slip to Rochester Way, A2 eastbound off-slip to Westhorpe Avenue, Westhorpe Avenue, Yorkshire Grey, Eltham Road, Lee High Road, Lewisham High Street, Rennell Street, Loampit Vale, Loampit Hill, Lewisham Way and New Cross Road to normal route of travel. Eastbound traffic via Amersham Road, Lewisham Way, Loampit Hill, Loampit Vale, Rennell Street, Lewisham High Street, Lee High Road, Eltham Road, Yorkshire Grey, Westhorpe Avenue, A2 westbound on-slip to Rochester Way, Rochester Way, A2 northbound off-slip to Shooters Hill Road, Blackheath Hill and Blackheath Road to normal route of travel.
