ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 TEMPORARY TRAFFIC RESTRICTIONS – WYATT PARK ROAD, MOUNTEARL

GARDENS AND SUNNYHILL ROAD 1. NOTICE IS HEREBY GIVEN that, to enable cover replacement and water works to be

- carried out by Thames Water, the Council of the London Borough of Lambeth intend to make an Order the effect of which would be to temporarily:-
 - (a) ban vehicles from entering the following lengths of roads:-
 - (i) that length of Wyatt Park Road which lies between the party wall of Nos. 58 and 60 Wyatt Park Road and the party wall of Nos. 68 and 70 Wyatt Park Road (an alternative route for affected vehicles would available via Normanhurst Road, Wavertree Road. Davsbrook Road and vice versa):
 - (ii) that length of Mountearl Gardens which lies between the party wall of Nos. 93-103 Mountearl Gardens and Nos. 105-115 Mountearl Gardens and the southern property boundary of Nos. 117-127 Mountearl Gardens (the alternative routes for affected vehicles would be available via (1) Mount Nod Road and Leigham Court Road; and (2) Leigham Court Road, Rosedene Avenue, Stockfield Road and Mount Nod Road);
 - (iii) that length of Sunnyhill Road which lies between the party wall of Nos. 158 and 160 Sunnyhill Road and the party wall of Nos. 164 and 166 Sunnyhill Road (an alternative route would be available via Valley Road and Wellfield Road and vice versal:
 - (b) ban the right turn by vehicles from the north-eastern arm of Mountearl Gardens culde-sac (from housing Nos. 110-120 Mountearl Gardens) into Mountearl Gardens:
 - (c) ban the right turn by vehicles from the south-western arm of Mountearl Gardens:
 cul-de-sac (from housing Nos. 14 to 32 Mountearl Gardens) into Mountearl Gardens:
 - (d) ban the left turn by vehicles from the north-eastern arm of Adare Walk into Mountearl Gardens;
 - (e) ban the left turn by vehicles from the south-western arm of Adare Walk into Mountearl Gardens.
- 2. The bans would only apply at such times and to such extent as shall be indicated by the placing of the appropriate traffic signs.

 3. The Order would come into force on 17th November 2022 for a maximum duration of 6 months or until the works have been completed, whichever is the sooner. In practice, it
- 6 months or until the works have been completed, whichever is the sooner. In practice, it is anticipated that the works would be completed on (a) 17th November 2022 for 1 day on Wyatt Park Road; (b) 21st November 2022 for 1 day on Mountearl Gardens; and (c) 23rd November 2022 for 1 day on Sunnyhill Road. If the works cannot be carried out or completed during this time then the Order may have effect at subsequent times within the maximum period of 6 months.
