The Lewisham (Housing Estate Roads and Car Parks) (Amendment No. *) Order 202* 1. NOTICE IS HEREBY GIVEN that Lewisham Borough Council propose to make the

- abovementioned Order under the powers of sections 6, 35, 45, 46, 49 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended. 2. The general effect of the Order would be:
- of housing estate properties in: (i) Forest Estate, introducing double yellow line 'at any time' waiting restrictions in

(a) to introduce parking controls in housing estate roads and car parks in or in the vicinity

- parts of Knapdale Close, Eliot Bank and Grizedale Terrace. Certain lengths of these roads would have no restrictions applying to them, allowing for vehicles to be parked on those lengths and it is intended that the existing informal parking places on grassed areas would be removed. Parking on any grassed area or area
- with hatched markings would be prohibited; (ii) Buckley Close, introducing 'at any time' waiting restrictions on both sides of the
- road outside Nos. 12 to 19 Buckley Close; (b) within Winslade Estate, to remove double yellow line 'at any time' waiting restrictions and replace them with residents' parking places outside Eynsford House, Lamberhurst
- House, Lullingstone House, Otford House and Sissinghurst House; (c) within the roads and car parks outside Burnett House and Lacey House: (i) to remove
- a resident permit holders parking place for two vehicles and an electric vehicle
- recharging point parking place for one vehicle and replace them with double yellow line 'at any time' waiting restrictions on the north-west side, adjacent to Nos. 1 to 8
- Burnett House; (ii) to extend a resident permit holders parking place by 5 metres,
- replacing double yellow line 'at any time' waiting restrictions on the south-east side,
- opposite Nos. 9 to 15 Burnett House; and (iii) to reconfigure the resident permit holders parking place and double yellow line 'at any time' waiting restrictions in the parking area adjacent to Nos. 1 to 12 Lacey House; and
- (d) within Tanners Hill Estate: (i) to remove double yellow line 'at any time' waiting
- restrictions and replace them with a hatched area to protect a secure cycle hanger in
- - the road fronting Deloraine House; and (ii) to remove a resident permit holders parking

 - place for two vehicles and replace it with double yellow line 'at any time' waiting
 - restrictions in the road fronting Heston House.
