## ROAD TRAFFIC REGULATION ACT 1984

### THE A201 GLA ROAD (BLACKFRIARS BRIDGE/BLACKFRIARS ROAD/NEW BRIDGE STREET, LONDON BOROUGH OF SOUTHWARK AND CITY OF LONDON) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2022

1. Transport for London in consultation with the London Borough of Southwark hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable water connection works to take place on the A201 Blackfriars Road.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) entering or proceeding in a southerly direction on the A201 New Bridge Street/ Blackfriars Bridge/ Blackfriars Road between its junctions with Fleet Street and Southwark Street, local access will be maintained between Fleet Street and Blackfriars Bridge, except pedal cycles;
  - (2) entering or proceeding in a northerly direction on the A201 Blackfriars Road/Blackfriars Bridge between its junctions with Southwark Street and the Victoria Embankment eastbound off-slip to New Bridge Street, except pedal cycles.

The Order will also:

- (3) allow all vehicles to use the southbound bus gate on Blackfriars Bridge approach allowing vehicle to proceed northbound onto New Bridge Street;
- (4) allow two-way operation on Upper Ground between its junctions with Blackfriars Road and Rennie Street.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 7:00 AM on 22nd December 2022 and 7:00 PM on 16th January 2023 or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. Northbound traffic via Southwark Street, Southwark Bridge Road, Southwark Bridge, Queen Street Place, Upper Thames Street and Puddle Dock and Queen Victoria Street to normal route of travel. Or via Stamford Street, Waterloo Roundabout, Waterloo Road, Waterloo Bridge, Lancaster Place, Aldwych, Strand, Fleet Street, Fetter Lane, New Fetter Lane, Charterhouse Street and Farringdon Street to normal route of travel. Southbound traffic via New Bridge Street northbound, Fleet Street, Strand, Lancaster Place, Waterloo Bridge, Waterloo Road, Waterloo Roundabout and Stamford Street to normal route of travel.
