THE A302 GLA ROAD (VICTORIA STREET/ BRESSENDEN PLACE, CITY OF WESTMINSTER) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2022

1. Transport for London in consultation with the City of Westminster hereby gives notice that it intends to make the above named Traffic

- Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- 2. The purpose of the Order is to enable highway improvement and resurfacing works to take place on the A302 Victoria Street/ Bressenden Place.
- 3. The effect of the Order will be to prohibit any vehicle from: (I) entering, exiting or proceeding in an easterly direction on Victoria
 - Street between its junction with Bressenden Place and No.88 Victoria Street; (2) entering, exiting or proceeding in a westerly direction on Victoria
 - Street between its junctions with Vauxhall Bridge Road and Wilton Road; (3) entering or proceeding on Bressenden Place between its junctions with Buckingham Palace Road and Victoria Street, local access will
 - be maintained between Buckingham Palace Road and No.2 Cardinal Walk: (4) stopping on Bressenden Place between its junctions with
 - Buckingham Palace Road and Victoria Street;
 - (5) entering, proceeding or stopping on Carlisle Place between its junctions with Ashley Place and Victoria Street;
 - (6) turning left from Bressenden Place into Victoria Street eastbound; The Order will also:

- (7) permit all vehicle to turn right from Victoria Street westbound into Buckingham Gate;
- (8) allow two-way operation on Bressenden Place between its junctions with Buckingham Palace Road and Victoria Street;

Works will be phased such that some restrictions will apply only at

- The Order will be effective at certain times from 9:00 PM on the 12th December 2022 until 7:00 PM on 1st May 2024 or when the works have
- been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- The prohibitions will not apply in respect of:
- (I) any vehicle being used for the purposes of those works or for
 - fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for
- indicated by traffic signs. For Victoria Street westbound closure via Buckingham Gate, Buckingham Palace Road and Grosvenor Gardens to normal route of travel. For Bressenden Place closure via Buckingham Gate to normal route of travel. For Carlisle Place closure via Victoria Street, Vauxhall Bridge Road, Rochester Row, Willow Place and Francis Street to normal route of travel. For Bressenden Place banned left via Victoria Street, Grosvenor Gardens, Lower Grosvenor Place and Buckingham Gate to normal route of travel.
