ROAD TRAFFIC REGULATION ACT 1984

THE A22 GLA ROAD (GODSTONE ROAD, LONDON BOROUGH OF CROYDON) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2023 1. Transport for London having consulted the London Borough of Croydon

- hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.

 2. The purpose of the Order is to enable new water main installation
- works to take place at A22 Godstone Road.

 3. The effect of the Order will be to prohibit any vehicle from entering,
- exiting or proceeding on:
 (1) Godstone Road between its junctions with A22 Purley
 Road/Whytecliffe Road South/unnamed service road leading to Tesco
 Supermarket and its junction with Dale Road. Local access will be
 maintained on Purley Way between its junctions with Dale Road and
 the boundary of London Borough of Croydon with the County of
 - (2) Warren Road between its junctions with Downs Court Road and Friends Road.

The Order will be effective at certain times between 27th January 2023 and 28th February 2023 each night 9:00 PM to 5:00 AM or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- 4. The prohibitions will not apply in respect of:
 - (I) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - brigade, ambulance or police purposes;
 (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for
- 5. At such times as the prohibition is in force an alternative route will be indicated by traffic signs via A23 Brighton Road, A23 Farthing Way, A23 Brighton Road, A23 London Road North, High Street, A23 London Road South, London Road, A23 Princess Way, The Stations Roundabout, A25 Redstone Hill, A25 Nutfield Road, A25 High Street, A25 Bletchingley Road, A25 Castle Street, A25 High Steet, A25 Bletchingley Road, A25
- Redstone Hill, A25 Nutfield Road, A25 High Street, A25 Bletchingley Road, A25 Castle Street, A25 High Steet, A25 Bletchingley Road, A25 Godstone Road, A25 Bletchingley Road, A25 High Street, A25 Oxted Road, A22 Godstone By-Pass, A22 Godstone Interchange, A22 Godstone Hill, A22 Godstone Road, A22 Caterham By-pass, A22 Waspes Lodge Roundabout and to normal route of travel and vice versa; Higher Drive, Cullesden Road, Firs Road, Park Road and Hayes Lane to normal route of travel and vice versa; Downs Court Road, Mitchley

Avenue and Coombe Wood Hill to normal route of travel and vice versa.
