

LONDON BOROUGH OF LAMBETH

REMOVAL AND INTRODUCTION OF DISABLED PERSONS PARKING PLACES IN VARIOUS ROADS WITHIN THE BOROUGH

[NOTE: This Notice is about the removal of certain disabled persons' parking places where they are no longer required and the introduction of new disabled persons' parking places where they are needed.

In controlled parking zones, this would involve (a) the introduction of new parking space where the disabled persons' parking places are removed; and (b) the removal of existing parking space to accommodate the new disabled persons' parking places.]

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth on 22nd February 2023 made the Lambeth (Charged-For Parking Places) (Amendment No. 2) Order 2023 and the Lambeth (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No. 2) Order 2023 under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The Orders will come into force on 27th February 2023.

2. The general effect of the Orders will be:-

- (a) to remove the disabled persons' parking places from the locations specified in Schedule 1 to this Notice;
- (b) to move the existing disabled persons' parking place outside No. 106 Glennie Road eastward so that it lies outside Nos. 106/108 Glennie Road and install a new disabled persons' parking place adjacent to this that will lie outside Nos. 104/106 Glennie Road;
- (c) to introduce new disabled persons' parking places at the locations specified in Schedule 2 to this Notice (these parking places would operate at any time and be for the use of vehicles displaying a disabled person's "blue badge" only); and
- (d) where the locations are in a controlled parking zone, to extend any parking space adjacent to the locations specified in Schedule 1 to this Notice so as to replace the disabled persons' parking places that will be removed, and to remove any existing parking space at the locations specified in Schedule 2 to this Notice so as to accommodate the new disabled persons' parking places.

3. The Orders are necessary to remove certain disabled persons' parking places where they are no longer required and to provide new disabled persons' parking places so as to improve parking facilities for disabled persons where they are needed.

6. If any person wishes to question the validity of the Orders or of any of their provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Orders are made, apply for the purpose to the High Court.

(Locations of disabled persons' parking places to be removed)

Babington Road (outside Nos. 19 to 23); Bloomhall Road (outside No. 18); Burnbury Road (outside No. 4); Elms Crescent (outside Nos. 98/100); Fentiman Road (outside No. 4); Fieldhouse Road (outside No. 7 and outside No. 29); Gipsy Road (outside No. 165); Grayscroft Road (outside No. 12); Ladas Road (outside Nos. 66/68); Liberty Street (outside block Nos. 67 to 72); Rosebery Road (outside Nos. 7/9; and Sudbourne Road (outside No. 11).

SCHEDULE 2

(Locations of disabled persons' parking places to be provided)

Brading Road (outside No. 2); Canterbury Grove (outside Nursery House); Carlisle Lane (adjacent to the vehicular entrance to Penhurst Place); Egremont Road (outside Nos. 10/12); Fairmount Road (outside Nos. 53/55); Hemberton Road (outside Nos. 27/29); Penistone Road (outside No. 15); St Louis Road (outside Nos. 1/3); St Saviours Road (at the side of No. 200 Brixton Hill and outside No. 1 St Saviour's Road); Sternhold Avenue (outside Nos. 137/139); Tremadoc Road (outside No. 3); Trinity Gardens (outside No. 22); Tyers Terrace (12.8 metres north-east of the north-eastern wall of No. 33 Tyers Terrace); Western Road (at the side of Nos. 93 to 105 St James' Crescent).
