The Lewisham (Various Roads)

(Thames Water Lead Replacement Project)

(Temporary Prohibition of Traffic) (No.8) Order 2023

NOTICE IS HEREBY GIVEN that Lewisham Council intend to make the above named temporary traffic order under the provisions of section 14 (1) of the Road Traffic Regulation Act 1984 because of Thames Water works on and adjacent to the highway. The effects of the order shall be as indicated below.

1. (1) Road closure and no parking/waiting in:

(i) Trewsbury Road, SE26; between northern boundary of No.22 Trewsbury Rd and Cator Road; (6th to 8th March) (ii) Hillmore Grove, SE26; between 14/16 Hillmore Grove and 24/26 Hillmore Grove; (7th to 9th March) (iii) Broseley Grove, SE26; between Hillmore Grove and rear boundary of 15 Broseley Grove; (7th to 9th March) (iv) Rubens Street, SE6; between Cameron Road and 14/16 Rubens Street; (8th to 10th March) (v) Tugela Street, SE6; between Rubens Street and 10/12 Tugela Street; (8th to 10th March) (vi) Riverview Park, SE6; between Vineyard Close and 21/23 Riverview Park; (8th to 10th March) (vii) Blythe Vale, SE6; between Stanstead Road and Marler Road; (9th to 15th March) (viii) Marler Road, SE6; between Blythe Vale and Carholme Road; (9th to 15th March) (ix) Bexhill Road, SE4; between Ewhurst Road and Brightling Road; (13th to 15th March) (x) Rushford Road; SE4; between Bexhill Road and 1/3 Rushford Road; (13th to 15th March) (xi) Pattenden Road, SE6; between Catford Hill and 8/10 Pattenden Road; (13th to 20th March) (xii) Ackroyd Road, SE23; between Bovill Road and 21/23 Ackroyd Road; (14th to 17th March)

(2) The diversion routes for traffic affected by the prohibitions shall be via local neighbouring roads and will be as signed on the ground.

2. Exemption will be provided in the order for vehicles engaged on the works, vehicles being used for ambulance, fire brigade or police purposes in an emergency and anything done with the permission or at the direction of a police officer.

3. The order is intended to come into force on the 27th February 2023 to remain in force for 3 months or until the works are complete, whichever is the sooner.

4. The prohibitions will apply as, when and to the extent signed on the highway.
