2) amend the hours of the exiting bay on Denmark Hill outside Nos.18-19 Camberwell Green to allow Taxi to use it, operation No Stopping at Any Day, except 7am-Ipm Loading (20 mins max), and Taxi Ipm-

 3) amend the hours of the exiting bay outside Nos. 4-6 Camberwell
 Church Street to allow Taxi to use it, operation No Stopping MondaySaturday 7am-7pm, except 10am-4pm Loading (20 mins max)
- Saturday 7am-7pm, except 10am-4pm Loading (20 mins max)
 Disabled Persons Vehicle (3 hours max), and Taxi 7pm-7am.

 The road which would be affected by the Order is the A202 GLA Road
 Camberwell Church Street and GLA Side Road Denmark Hill in the
- London Borough of Southwark.
