**The South Bank Centre Belvedere Road Lambeth London SE1 8XX** Temporary planning permission for a period of 2 years for retention of previously approved (ref. 17/05274/FUL) 43 concrete Hostile Vehicle Mitigation (HVM) barriers adjacent to Southbank Centre Square. 23/00814/FUL
