THE A202 GLA ROAD (VAUXHALL BRIDGE ROAD) A5205 GLA ROAD (ST JOHN'S WOOD ROAD) AND A41 GLA ROAD (PARK ROAD, CITY OF WESTMINSTER) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2023 1. Transport for London in consultation with the City of Westminster

- hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- 2. The purpose of the Order is to enable highway improvement works to take place on the A202 Vauxhall Bridge Road, A41 Park Road and A5205
- St John's Wood Road.
- 3. The effect of the Order will be to prohibit any vehicle from: (I) entering, exiting or proceeding on St John's Wood Road between its junctions with Wellington Road and Maida Vale, except pedal cycles, access will be maintained between Wellington Road and No.60 St
- John's Wood Road and between Maida Vale and No.34 St John's Wood Road: (2) stopping on St John's Wood Road between the boundaries of No.60
- & Lords View One and Nos.28 & No.34 St John's Wood Road; (3) entering Oak Tree Road at its junction with Lodge Road, residential
 - access will be maintained: (4) entering, exiting or proceeding on Park Road between its junctions
 - with Wellington Road/ Prince Albert Road and Rossmore Road, local access will be maintained between Rossmore Road and Grove
 - Gardens: entering, exiting or proceeding on Lodge Road between its junction
 - with Park Road and No.6 Lodge Road; (6) stopping in the Parking and Disabled Persons Vehicle bay outside
 - Nos.4 to 14 Lodge Road;
 - stopping on Park Road between its junctions with Wellington Road (7)and Grove Gardens;
 - (8)
 - stopping on Park Road between its junction with Kent Terrace
 - northern-arm and No.98 Park Road; (9)
 - exiting Chapter Street at its junction with Vauxhall Bridge Road;
 - (10) stopping on Chapter Street between its junctions with Douglas Street and Vauxhall Bridge Road;
 - (11) stopping on Vauxhall Bridge Road between its junctions with Chapter Street and Rampayne Street;
 - (12) exiting Francis Street at its junction with Vauxhall Bridge Road; (13) stopping on Vauxhall Bridge Road between its junctions with Gillingham Street and Upper Tachbrook Street;

with Vauxhall Bridge Road and Willow Place.

- The Order will also:
- (14) suspend the pedestrian crossings on St John's Wood Road outside
- No.34 and northeast of Oak Tree Road;
- (15) suspend the pedestrian crossings on Park Road south of its junction with Lodge Road and Kent Terrace southern-arm;
- (16) suspend the pedestrian crossings on Vauxhall Bridge Road
- northwest of its junction with Chapter Street and northwest of Francis Street;

Rampayne Street;

- (17) allow two-way operation on Chapter Street between its junctions
- (18) permit all vehicles to use the south-eastbound bus lane on Vauxhall
- (19) allow two-way operation on Francis Street between its junctions
- Works will be phased such that some restrictions will apply only at
- certain times. The Order will be effective at certain times between 12:01 AM on the 4th March 2023 and 7:00 PM on the 5th October 2023 or when the
- works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- 4. The prohibitions will not apply in respect of: (I) any vehicle being used for the purposes of those works or for fire
- (2) anything done with the permission or at the direction of a police
- 5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs.
- (2) For Park Road closure via St John's Wood Road, Lisson Grove and Rossmore Road or reverse to normal route of travel. Dated this 3rd day of March 2023
