

# Transport for London Notice

## ROAD TRAFFIC REGULATION ACT 1984

### THE A205 GLA ROAD (WESTHORNE AVENUE, ROYAL BOROUGH OF GREENWICH) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2023

1. Transport for London in consultation with the Royal Borough of Greenwich hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable highway improvement and resurfacing works to take place on the A205 Westhorne Avenue.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) entering, exiting or proceeding on the southbound carriageway of Westhorne Avenue between its junctions with the A2 unnamed off-slip road to Westhorne Avenue and Yorkshire Grey Roundabout;
  - (2) entering, exiting or proceeding on the northbound carriageway of Westhorne Avenue between its junctions with Yorkshire Grey Roundabout and the A2 unnamed off-slip road to Westhorne Avenue;
  - (3) stopping on Westhorne Avenue between its junctions with the A2 unnamed off-slip road to Westhorne Avenue and Yorkshire Grey Roundabout;
  - (4) entering or proceeding Lionel Road/ Haimo Road and Horsefield Road between their junctions with Greenway and Westhorne Avenue, local access will be maintained;
  - (5) entering or proceeding Legatt Road/ Philippa Gardens/ Knockholt Road/Katherine Gardens and Pinnell Road between their junctions with Shawbrooke Road and Westhorne Avenue, local access will be maintained;
  - (6) entering or proceeding Greenway between its junctions with Lionel Gardens and Westhorne Avenue, local access will be maintained;
  - (7) entering or proceeding Legatt Road between its junctions with Keeling Road and Westhorne Avenue, local access will be maintained;

The Order will also:

- (8) permit two-way operation on Greenway between its junctions with Lionel Gardens and Westhorne Avenue;
- (9) permit two-way operation on Eltham Green between its junctions with Eltham Green Road and Westhorne Avenue;
- (10) permit two-way operation on Keeling Road between its junctions with Legatt Road and Westhorne Avenue.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 20th March 2023 and 20th September 2023, every night 9:00 PM until 5:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For Westhorne Road southbound via the A2 northbound on-slip, A2 Rochester Way Relief Road, A2 off-slip road to Kidbrooke Park Road, Kidbrooke Park Road and Eltham Road to normal route of travel. For Westhorne Road northbound via Yorkshire Grey Roundabout, Eltham Hill, Eltham High Street, Well Hall Road, Well Hall Roundabout and A205 Rochester Way to normal route of travel.
