

# Transport for London Notice

## THE ROAD TRAFFIC REGULATION ACT 1984

### THE A24 GLA ROAD (LONDON BOROUGHES OF WANDSWORTH AND MERTON) (SPEED LIMITS) ORDER 2023

1. Transport for London, hereby gives notice that it intends to make the above named Order under section 84 of the Road Traffic Regulation Act 1984.
2. The general nature and effect of the Order would be to impose a speed limit of 20 MPH speed limit on the A24 GLA Roads – Balham Hill/ Balham High Road/ Upper Tooting Road/ Tooting High Street and High Street Colliers Wood/ Priory Road and Christchurch Road and all GLA Side Roads - Red Route returns of these roads in the London Boroughs of Wandsworth and Merton.
3. The roads which would be affected by the Order are the GLA Main Roads and all GLA Side Roads - Red Route returns of these roads in the London Boroughs of Wandsworth and Merton as listed in article 2 above.
4. The roads affected are currently subject to a permanent speed limit of 30 MPH.
