

# Transport for London Notice

## ROAD TRAFFIC REGULATION ACT 1984

### THE A302 GLA ROAD (BRESSENDEN PLACE) AND A3214 GLA ROAD (BUCKINGHAM PALACE ROAD, CITY OF WESTMINSTER) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2023

1. Transport for London hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable crane operation works to take place on the A302 Bressenden Place and A3214 Buckingham Palace Road.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) entering, proceeding or stopping on Bressenden Place between its junctions with Buckingham Palace Road and Victoria Street;
  - (2) entering or proceeding in a northerly direction on Buckingham Palace Road between Eccleston Street and Lower Belgrave Street;
  - (3) entering or proceeding in a northerly direction on Buckingham Palace Road between Ebury Bridge/ Pimlico Road and Eccleston Street, local access will be maintained;
  - (4) entering or proceeding in a southerly direction on Buckingham Palace Road between Victoria Street and Elizabeth Bridge, except local buses between Victoria Street and Terminus Place;
  - (5) entering or proceeding in a southerly direction on Buckingham Palace Road between Bressenden Place and Victoria Street, local access will be maintained;
  - (6) stopping on Buckingham Palace Road between Victoria Street and Elizabeth Bridge.

The Order will also suspend the western footway on Buckingham Palace Road between Eccleston Street and Lower Belgrave Street.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 28th April 2023 and 30th October 2023, every Friday at 10:00 PM until Monday at 5:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. **For Bressenden Closure** via Buckingham Palace Road, Elizabeth Bridge, St George's Drive, Lupus Street, Bessborough Street, Drummond Gate, Vauxhall Bridge Road, Bessborough Gardens, Millbank, Horseferry Road, Greycoat Place, Artillery Row and Victoria Street to normal route of travel. **For Buckingham Palace Road northbound closure** via Ebury Bridge, Warwick Way, Belgrave Road, Gillingham Street, Wilton Road and Victoria Street to normal route of travel. Or via Pimlico Road, Lower Sloane Street, Sloane Square, Cliveden Place, Eaton Gate, Eaton Square and Lower Belgrave Street to normal route of travel. **For Buckingham Palace Road southbound closure** via Bressenden Place, Victoria Street, Grosvenor Gardens, Hobart Place, Eaton Square, Eaton Gate, Cliveden Place, Sloane Square, Lower Sloane Street and Pimlico Road to normal route of travel.
