ROAD TRAFFIC REGULATION ACT 1984

THE A232 GLA ROADS (CHEPSTOW ROAD AND FAIRFIELD ROAD, LONDON BOROUGH OF CROYDON) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2023

1. Transport for London in consultation with the London Borough of Croydon hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable highway improvement and resurfacing works to take place on the A232 Chepstow Road and Fairfield Road.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering, exiting, proceeding or stopping on the A232 Fairfield Road/ Chepstow Road between its junctions with Addiscombe Grove and Chepstow Rise;
 - (2) entering, exiting, proceeding or stopping on Park Hill Road between its junctions with Granville Close and No.35 Park Hill Road;
 - (3) entering or proceeding in a northerly direction on Chepstow Rise between its junctions with Fleetwood Close and Chepstow Road;
 - (4) entering or proceeding in an easterly direction on Barclay Road between its junctions with Park Lane and Addiscombe Grove, local access will be maintained;
 - (5) entering or proceeding in a westerly direction on the A232 Addiscombe Road/ Chepstow Road between its junctions with Shirley Road and Chepstow Rise, local access will be maintained.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times from 12:01 AM on 24th April 2023 until 11:59 PM on 24th October 2023 or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs via Park Lane, Coombe Road, Coombe Lane, Gravel Hill, Kent Gate Way, Addington Village Road, Addington Road, Glebe Way, High Street, Wickham Road, Shirley Road and Addiscombe Road to normal route of traffic.
