4. The Order would come into force on 30th May 2023 and would continue for a maximum duration of 8 months (to allow for contingencies) or until the works have been completed whichever is the earlier. In practice it is

In practice it is anticipated that the works would take place in phases between the 30th May 2023 and the 3rd August 2023, but if the works cannot be completed or carried out during that time the Order would also have effect at a subsequent time within the maximum period of 8 months.
