## ROAD TRAFFIC REGULATION ACT 1984

### THE GLA ROADS A3203 AND A3036 (LAMBETH ROAD AND LAMBETH PALACE ROAD, LONDON BOROUGH OF LAMBETH) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2023

1. Transport for London in consultation with the London borough of Lambeth hereby gives notice that it has made the above-named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable electrical duct installation works to take place on sections of the A3203 and A3036 GLA Roads Lambeth Road and Lambeth Palace Road.
3. The effect of the Order will be to prohibit any vehicle:
  - (1) from entering or proceeding on the north-eastbound carriageway of Lambeth Road between its junction with Lambeth High Street and the circulatory traffic system at the junctions of Lambeth Bridge, Lambeth Palace Road, Lambeth Road and Albert Embankment;
  - (2) from entering, exiting or proceeding on Lambeth High Street between its junction with Lambeth Road and the entrance to No.1 Lambeth High Street, local access to No.1 Lambeth High Street will be maintained;
  - (3) exceeding a maximum gross weight of 7.5 tonnes from exiting Lambeth High Street at its junction with Lambeth Road;
  - (4) from stopping on Lambeth Road between its junction with Lambeth High Street and the entrance to No.13 Lambeth Road (Novotel Hotel);

The Order will also allow all vehicles to use the westbound bus lane on:

- (5) Lambeth Road between the entrance to No.13 Lambeth Road (Novotel Hotel) and outside No.1 Albert Embankment.

The Order will be effective at certain times between the dates of 13th May 2023 and 11th June 2023, every Saturday at 8:00 AM until Sunday at 11:59 PM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs: Lambeth Road northbound diversion via Lambeth Palace Road, Westminster Bridge Road and Kennington Road to normal route of travel.
