ROAD TRAFFIC REGULATION ACT 1984

THE A205 GLA ROAD (DULWICH COMMON/ THURLOW PARK ROAD, LONDON BOROUGH OF SOUTHWARK) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2023

1. Transport for London hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable signal, highway improvement and resurfacing works to take place on the A205 Dulwich Common.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering, exiting or proceeding or stopping on Dulwich Common between its junctions with Rosebery Gate – Dulwich Park and Lordship Lane;
 - (2) entering or proceeding in an easterly direction on Dulwich Common between its junctions with College Road and Rosebery Gate – Dulwich Park, local access will be maintained;
 - (3) stopping on Lordship Lane between its junctions with Melford Road and Underhill Road;

The Order will also:

- (4) permit all vehicle to use the south-eastbound bus lane on Lordship Lane between its junctions with Melford Road and Underhill Road;
- (5) prohibit HGVs entering or proceeding in an easterly direction on the A205 Thurlow Park Road/ Dulwich Common between its junctions with Croxted Road and Lordship Lane.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times from 12:01 AM on 17th July 2023 until 11:59 PM on 31st December 2023 or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs via College Road, Dulwich Village, East Dulwich Grove and Lordship Lane or reverse to normal route of travel. HGV's via Croxted Road, Norwood Road, Herne Hill, Demark Hill, Champion Park, Grove Lane, Dog Kennel Hill, Grove Vale and Lordship Lane or reverse minus Croxted Road to normal route of travel.
